









Explore immediate and longterm alternative solutions to address space issues due to rapid student enrollment, if the next Bond Referendum fails.








City of West Fargo vs. West Fargo Public School District






History of District Boundaries

The Legislature required any school district without an operating school building be dissolved and attached to an adjacent district. This resulted in District No. 35 (area between Fargo and West Fargo including West Acres) becoming part of the West Fargo School District.

The WFPS School Board voted to annex Harwood and Horace into the West Fargo School District The Legislature froze the boundaries between the Fargo and West Fargo school districts.




Enrollment Projections




Operational, Preferred, and Maximum Capacities



- Maximum Capacity: The greatest number of students a given building can support with current class systems
 - Calculated at 24 students per instructional classroom at the elementary level
 - Calculated based on instructional square footage at secondary level
- 2. Preferred Capacity: Day-to-day capacity target for normal operations
 - Calculated at two fewer 24 student classrooms at elementary level (~92%)
 - Calculated at 90% of maximum capacity for secondary sites
- 3. Operational Capacity: Accounts for growth of special education specialized programs and other specials/electives
 - o Based on average class size chart (23), varies based on programming growth at elementary sites
 - not all schools have identical specialized programming
 - Not currently needed at secondary sites

Structured Learning Environment (SLC) - Federal IDEA requirement

Elementary


- CSSP 12 Classrooms
 - Berger (2), South (2), Eastwood (2), Brooks Harbor (3), Deer Creek (2), Horace Elem (1)
 - One (1) medically fragile and one (1) C+
- SLC 5 Classrooms (six last school year, but due to an educator resignation we closed a classroom)
 - o Independence (1), Legacy (2), Westside (2)
- Middle School
- CSSP 4 Classrooms
 - One at each Middle School, plus 1 C+ at HMS
 - O Two programs with 8 learners each and one program at 6.
- SLC 3 Classrooms
 - o One at each Middle School
 - o Four (4) open seats (2 at HMS, 2 at CMS)

High School

• The staffing is different at this level as there are not trained Behavior Technicians









- **1. Capacity Utilization:** 85-95% capacity of building; should neither be overcrowded nor under-utilized.
- 2. Continuity: Feeder Systems should be as consistent as possible ES->MS->HS Hawk/Mustang/Packer.
- **3. Diverse Schools:** School enrollments should be as balanced as possible in terms of backgrounds, socio-economic status.
- 4. Neighborhood Schools: Ensure students live as close to their school as reasonably possible, minimize bussing.
- **5. Stability:** New boundaries should serve for the longest potential time possible. Same address stays in the same building.

Potential Solutions to Address Overcrowding Without a Bond



- Adjust Boundary Lines
- Pull Grade Levels Out of Buildings
- Portables






Small Group Discussions





Which principle(s) should guide the Contingency Committee's work?









