Presiding Officer: Mr. Nicotera, President called the meeting to order at 6:03 p.m. Mr. Nicotera welcomed everyone to the meeting and thanked them for

attending.

Pledge of Allegiance: The pledge of allegiance was recited.

Presentation – Chief Brian Jaynes, a retired US Navy officer, and Captain Robert Shaw from Notre Dame came to present the program of NJROTC and NNDC. This benefits students from grade 8 to 12. Physical Education requirements are met if enrolled. There is no commitment to enroll in the service but if a student did after graduation, they would be placed a higher level than a newly recruit. Students must have a 75 grade average or higher. The program promotes patriotism, leadership and confidence along with many other good quality traits needed for the future growth of the students. If interested in offering the program to Sauquoit Valley students or if there are any questions, feel free to contact Chief Jaynes or Captain Shaw.

Budget Presentation(s): Charlie Cowen commented that there is no change in the budget. At this time the district is waiting for NYS to adopt its budget with final state aid figures to school districts. As the budget currently stands, the board is anticipating presenting a budget with a 5.5% tax levy increase to go to vote. Even with that increase there is currently a deficit of \$400k primarily due to a reduction in Foundation Aid per the Governor's budget proposal where the district was expecting a 3.0% increase to Foundation Aid. Once a final budget is adopted by NYS the district will finalize any necessary reductions and communicate them to the public at that time.
