# **Programs and Services**

The Atlanta Speech School builds the foundations for Deep Reading Brains and life-long learning. In each school and program, classrooms apply a model for building literacy foundations that is steeped in relationship, language acquisition, critical thinking and empathy – as developed by the Speech School in alignment with the latest neuro and social science.

The mission of the Atlanta Speech School is to help each person develop their full potential through language and literacy. We follow this mission so that every child can find their voice and go on to make the greatest difference in the lives of others.

### **Preschools:**

Through Atlanta Speech School preschools, each child is given the experience that ensures they have the best possible start in life.

Katherine Hamm Center Preschool focuses on language development and other literacy foundations for children who are deaf or hard of hearing. Children who are deaf or hard of hearing and enrolled in the Katherine Hamm preschool learn together with classmates whose parents are staff members here and in other area independent schools.

**Stepping Stones'** preschool setting centers language and literacy for children who are experiencing speech and language delays. Lead teachers are Speech-Language Pathologists who create personalized learning plans to guide each child forward on their educational path.

Anne & Jim Kenan Preschool has been part of the Atlanta Speech School for more than 50 years. Kenan serves preschoolers from across the city who are ready to form a pre-literacy foundation in a joyful, engaging and academic setting.

### Rollins Center for Language & Literacy:

Rollins Center for Language & Literacy extends the sciencebased instruction received by each child at the Atlanta Speech School to every child with the singular purpose of breaking the cycle of illiteracy for children whose families have been denied educational opportunity for generations. The Rollins Center does this through facilitation, professional development, and coaching in regional schools and on a global scale through its free online Cox Campus. Cox Campus has more than 275,000 members in 50 states and more than 100 countries.

### Wardlaw School:

Wardlaw School children are elementary-aged, bright children with dyslexia. Wardlaw's singular purpose is the construction of each child's Deep Reading Brain. Wardlaw staff expect and teach more than reading proficiency, ensuring that when a child leaves Wardlaw, they are uniquely prepared to be citizen contributors - with the empathy, critical thinking and executive functions that the future world demands.

### The Clinic:

The Atlanta Speech School Clinic offers supplemental language and literacy support and services to children at the School and across Georgia.

- Learning Lab helps each child grow to become the student they are meant to be by helping them develop essential academic. With a central focus on literacy, Learning Lab instructors work to teach decoding, reading fluency and comprehension, written expression, math skills and study skills.
- Pediatric Occupational Therapy is offered to support children from infancy to adolescence in the areas of sensory processing, self-regulation, gross and fine motor coordination and other areas that may contribute to their confidence and success in daily life.
- Speech and Language services include evaluation and therapy provided by SLPs for children and young adults. Our Clinic offers comprehensive and individualized speech, language and literacy services in our School programs, in our local community and nationally through telepractice. All full-time staff are certified Wilson Dyslexia practitioners.
- Audiology services are provided in partnership with Pediatric Earn Nose and Throat of Atlanta (PENTA) and include diagnostic testing, evaluation and remediation for infants, children and adults.

### 2023 REVENUES FROM OPERATIONS



The Statement of Activities and Changes in Net Assets shows an increase in net assets of \$4,145,000 for the year ended May 31, 2023. The change from last year's decrease in net assets of \$5,983,000 is due primarily to an increase in investment income of \$5,024,000 compared to 2022. Contributions increased by \$4,888,000 in 2023 compared to 2022.



A named endowment fund is established as a permanent gift that will benefit the Atlanta Speech School's children now and for generations to come. 

An initiative developed by the Katherine Hamm Center, AtL's mission is to ensure that all families who have a baby who fails the newborn hearing screening experience a streamlined and effective system for screening, diagnosis, and early intervention for their child. AtL creates an ecosystem of support around the family that includes a child-specific guide map which details all appointments from diagnosis to Early Intervention, reliable transportation assistance, and a Parent Navigator who offers reassurance along the way.
