SUMMARY

Provide ongoing provision of mandated mental health service to eligible Special Education students. School based mental health services also include the development and coordination of a multi-disciplinary internship program as well as a coordination and collaboration with general education programs with the goal of improving all students' mental health and resiliency.

NATURE AND SCOPE

Under the direction of the Special Education Directors within the Tri Valley SELPA the Clinical Director oversees the provision of school based mental health services to eligible students. The Clinical Director is responsible for all aspects of school based mental health services including program administration and development, supervision of assessments, provision of outpatient services, school based mental health services and case management of students placed in day treatment and residential facilities.

- Prepare and compete all required documentation and reports for students including LEA
