



Calvert County Public Schools has a Virtual Asynchronous Instructional Day of School scheduled for staff and students on Tuesday, May 14, 2024.

What will virtual instruction look like for May 14, 2024?

Staff will develop review assignments for students that can be completed for asynchronous instruction. Students can access assignments during their regularly scheduled school hours, where the first two hours of school are dedicated to students working to independently complete asynchronous assignments provided by their teachers. Class time will be provided by all teachers using Teams links. Some teachers may set up Teams meetings on calendars to meet directly with individual or small groups of students.

Students in grades PreK-2 will have a paper packet sent home with students prior to Tuesday, May 14. Packets with the completed work should be returned to school the next day. Students in grades 3-12 can access Schoology to complete assignments posted for their classes. Students will be made aware of the assignments posted in Schoology prior to Tuesday, May 14.

Students on May 14 will learn in various ways. This may include (but not limited to) such engagement activities as:

- Video lessons with timed student responses
- Scheduled review activities with or without virtual teacher assistance
- Games or activities to be completed in a home environment
- Schoology assignments which include review of content
- Open Teams for "class time" of individualized assistance

Teachers and schools will provide information in advance about where to access Teams links, materials, or resources.

What do students do if they do not have access to the internet at home?

Parents/Guardians should contact their child's teacher so that a paper packet can be provided to the student prior to May 14. How will student attendance be monitored?

Students in grades PreK-2 will demonstrate their involvement by completing the paper packet provided. Completed work returned to school will account for their involvement on the Virtual Asynchronous Instructional Day. Students in grades 3-12 will log into Schoology to complete class assignments to show their involvement in the day's instructional activities. Attendance will be monitored through the completion of instructional activities, which may include a brief survey to take attendance, submission of assignments, or login to a Teams Meeting. Please follow the instructions provided by your child's teacher for the completion of assignments.

Is it a full day?

Yes. As the day was scheduled as a virtual day of instruction, students will have their normal scheduled school hours to complete assignment provided for the day.
