Highlights from January 23, 2024 Presentation

- USBE provides model policies regarding cell phone use
- SLCSD mirrored a state model policy when creating S-11: Administrative Procedures, Student Electronic Devices in Schools
- Schools, using a shared governance process, create their own guidelines and rules for the use of cell phones at and during school



Board Policy S-11: Student Electronic Devices in Schools

The Salt Lake City School District Board of Education recognizes that, depending on how a personal electronic device is used, it may be either a valuable instructional tool or a source of disruption.

In consideration of expanding technologies and the prevalence of electronic devices in our society, the board allows the responsible use of cell phones and other electronic devices at school in accordance with all applicable state laws, school rules and district administrative procedures.


Students who possess and/or use such devices at school or school sponsored events must be respectful of the educational environment and the rights and privacy of all individuals within the school community.




Survey Overview

- Responses are grouped by elementary, middle, and high school


All Stakeholders Question: Are you familiar with the cell phone policy at your school?




Teacher Question: On average, how often do you allow students to use their cell phones in your classroom for instructional reasons?




Teacher Question: On average, how often do you allow students to use their cell phones in your class for personal reasons?




Parent Question: On average, how often do you communicate with your student during school on their cell phone?

Board Report April 16, 2024

Cell Phone Use Survey Open Response Comments

Following are the free response comments from the survey administered to parents, K-12 students, and K-12 teachers during February – March 2024. There were over 4,000 responses from parents, 5,000 responses from students, and 500 responses from teachers. The question prompt "What concerns do you have about the cell phone policy?" resulted in 2,300+ unique responses.

Some major themes that emerge from these comments about K-12 school cell phone rules include:

- Inconsistency and Enforcement: Many comments highlight the challenges of enforcing a school's cell phone rules consistently across classrooms and the school. Respondents express frustration when rules are not enforced consistently, resulting in inconsistent consequences for students who violate the school's rules.
- Educational Use vs. Distraction: There are conflicting opinions about the educational value of cell phones versus their potential as distractions. Some respondents, especially students, advocate for using phones as educational tools (e.g., taking notes or accessing educational resources). However, other respondents state that cell phones disrupt the learning environment.
- Parental Involvement and Communication: The role of parents in supporting cell phone rules is
 emphasized; parent support is needed to implement the school's rules about usage during the day.
 However, some parents and students indicate they communicate with their student throughout the
 day and indicate that cell phones are important in maintaining contact; they feel their student
 should have access to their phone during the day.
- Safety Concerns: Both positive and negative comments were made about safety issues related to cell phone use. Some respondents expressed concern about cyberbullying and excessive screen time. Others noted how important it is to be able to communicate during critical situations.
- Teacher Empowerment and Support: Teachers express a need for clear guidelines, support from school administration and parents, and consistent consequences for students who violate school cell phone rules.
- Access and Support in the Classroom: Not all students have access to a cell phone; therefore, asking a student to use a cell phone to support classroom instruction leads to disparities in educational experiences and outcomes. Many students indicate that they choose to use cell phones for schoolwork.
- Digital Citizenship: Comments express the importance of teaching students to be responsible
 digital citizens, including knowing when and how to use technology appropriately for educational
 purposes.

Addressing these issues will require schools to follow the guidelines provided in Board Policy S-11: Student Electronic Devices in Schools to develop a site-based plan for cell phone use at school. The plan should be developed with input from students and parents, include ongoing education about digital literacy and responsible device use, and be consistently enforced.

What concerns do you have about the cell phone policy?

PARENTS

"The cell phone policy that I am familiar with: Phones and smart watches should be shut off and put away during the day. If a student is using one of these devices while at school they will first receive a warning and be asked to put it away. On the second time using a device without permission they will receive an accountability ticket. The third time a device is being used without permission it will be taken to the office and a family member will need to pick it up. If you need to reach your student please call the school at 801-578-8150 and we will either give them a message or connect you to them directly."

My child has a smart watch, which is disabled for all but telling time during the school day. This disabling can be overridden in an urgent situation - I assume that we are in compliance with the policy and we have had no issues. It is important to me that my child have this watch on their person during they day.

A complete ban is not a realistic solution. There could be alternatives to keeping cell phones out of the classroom. I like the idea of limiting cell phone use but a ban is not the best solution.

A need to balance an undisturbed classroom and learning environment with student safety.

Access to mobile phone in case of emergency.

Agree there shouldn't be any

All my concerns have been fully addressed, I say good day.

All students should not have them at school.

Answer to the next question since it was not offered - how many times do I communicate with my child at school? 1-3 times a week. Not never, and not 1-3 times a day. The answers need to be rewritten.

As a parent I worry about emergencies. Unfortunately, we live in a world with mass shootings and I think we need to have cell phones for emergency purposes. I hope there can be ideas of how to implement rules where phones can be used for this particular situational circumstance if and when necessary.

As far as I can tell, there is no cell phone policy. A few teachers ask that students put their phones away during class, but according to my daughter, they are allowed to have them out during "breaks". The effect seems to be that students have no compunction about being on phones during class. My daughter once sent a picture of a girl sitting next to her watching TikTok videos during math. My daughter certainly spends far too much recreational time on her phone during school hours. I would prefer that cell phones be prohibited during school hours. My answer to the question below reflects my daughter's preferences & habits, not mine; I would gladly go without getting texts from her during school hours.

As long as student is able to use there phone after school there is no need for them to be distracted by it during class

as long as they are not allowed to use it unless it's an emergency, and i would only call if it was, then i would be ok with it.

Ban the phones!

Can we PLEASE take cell phone use more seriously at school? It is so distracting and teens don't have the will power to put the phone down, (most parents don't either). I would support a strict no phone use policy at school please!

Cell phone policy has always been that students have access to their phones throughout the entire day and can do homework on their cell phones when necessary this provides us as parents to be able to communicate with our students when necessary. And we feel with this being an alternative type of school Being non-traditional should continue to be so. Student should have the right to use their cell phones as necessary.

Cell phones are a distraction and bad for mental health. I have no problem with banning them (or locking them up during class time).

Cell phones are too much of a distraction and I feel that they should not allowed in the school. However, the more limited functionality of watches with cellular capability is acceptable to me but with rules to keep them quiet or mute in classrooms.

I agree with the policy. My child used to have a smart watch which was really useful especially when I'm late picking her up I can just text her and let her know so she won't get worried. School time is really good you can put it on so not disturb while she is in school,

I am concerned it may not be followed well enough at times. Students should not have their phones as they do present a distraction and can violate student privacy.

I am concerned that my kids are getting distracted by their devices at school. Also, we have parental restrictions on their iPhones, but our kids said they needed Chrome for schoolwork, and we aren't able to restrict gaming or social media on Chrome. This may be a way the kids try to outsmart their parents. The often "HAVE" to have their devices for "HOMEWORK" even if they've already been using them for entertainment. It makes it hard for us parents to help the kids regulate their screen time when they always need the devices for "homework."

I am concerned that the policy may not limit smart watches. I understand why a parent would want them for transitioning to and from school but while in the classroom I think they can be too distracting. I would be in favor of altering the policy to include smart watches especially with younger kids who are not mature enough to know when it is appropriate to use it and when it is not. Leaving it in their backpack during school is a great solution.

I am for a policy of no cell phones during school.

I am in favor of no phones or smart watches in school.

I am not aware of the policy.

I am not familiar, but i would like to see more strict when it comes to phones.

I am not sure of the school's policy, but occasional communication with my student has been key.

I am unsure about the policy

I am worried about my student not being able to use his phone during lunch, or before school for academic purposes. My child has also said that he needed to use it as a translator while he was waiting for the other student to get a translation device.

I appreciate the policy still allows phones as long as they stay out of sight during class. I do think it gets confusing when a teacher uses access to cell phones as a reward. I would rather the policy always be enforced as "they stay out of sight".

I appreciate the school taking action on phones/watches.

I believe a general policy that allows students to have their phones for safety concerns yet not allow them for general use during class would be appropriate.

I believe all children should have access to their cell phones for emergencies

I believe the students should have access to their phones, as appropriate for that class. I don't agree with 'locking' them up as they enter. There have been times I have been grateful to know exactly what is going on in class. For my child's safety and learning conditions.

I believe the use of cell phones in older students class rooms to submit homework or to use in the efforts to complete homework or work within the classroom. The cellphone should not be used for personal use. If the student needs to contact a parent they need to go to the office within the elementary school.

I believe they shouldn't be used during school hours or during classes. Lunch time I think is okay I just want to have that connection with my child just in case something is wrong and they need help. Not all students are comfortable enough to express their feelings to a faculty member.

I don't mind that they can't have it on but I believe they should be allowed to keep it on their persons and on silent incase of an emergency both at home and at school. There have been times where I needed to reach out to my son and I would just leave him a text and ask him to call me at his first convenience. Also there have been instances at school where things happen on the outside and the media makes it sound all big but getting a text that everything and everyone is safe inside has been a relief.

I don't see a reason to have cell phones out during class when each student has a cell phone.

I don't since my child does not bring a cell phone to school

I feel as I am the parent and gave my child a phone that it isn't upto the school/teacher to decide when or where my child can have the phone unless it's a distraction

I feel children should have a cell phone, but not use it during class time, unless an emergency. Cell phones during school time should only be used for emergencies. The only time I communicate with my child during the school day is, if he needs to be picked up or if he has an appointment(rarely). After school, when I pick him up, I will text him to let him know that I am in the parking lot. Of course, before the city buses 919 and 920 were eliminated - I didn't need to text my child, because he/they would always ride the bus home

I feel I'm the parent and should be able to make decisions about when and where my child has their phone. If their not disrupting the class with it and paying attention in class then they should be able to have their phone on them at all times.

I feel like communication between parents and students is important. We live in a digital world and ensuring students and parents can communicate is important. It's easier and less disturbing to text my student than having to call a secretary and hoping she/he relays the message. I understand that phones shouldn't be out during instruction but it seems silly to not allow them at all.

I feel like kids should have access to their phones (with an expectation they are on silent and/or in backpacks - that's fine).

I feel like there my be times when my son would benefit from the use of his cellphone for helping him with spelling or even calming him down when he needs it.

I feel secure in knowing she has a way to get in touch with me if needed or if I have a message to relay to her that she is able to get it. Plus, I like to track her whereabouts

I feel that cell phones should not be allowed on campus at all.

I feel that most students use their phones for the right purposes. I like that I can communicate with my student if needed but never during class.

I guess it's concerning that I don't even know what the policy is.

I have concerns about all devices including smart watches that I have seen children be very distracted by when in classroom. I don't allow my child a watch at school for this reason. Middle school is even more of a challenge with so many kids constantly distracted by their phones. There should be a no phone policy enforced.

I have had an older child call me from school during a lock down before. It was highly comforting to me and them. I'm concerned as gun violence is a real risk that my child will be alone in their last moments of life or during a traumatic and dangerous situation, not being able to contact a parent. So I guess it's more of a gun violence issue. But that is my only concern about the cell phone policy.

I have heard great things about cell phone free schools and lunch rooms. I hope Whittier follows that in older grades. (Not sure because my son is younger)

I just feel that in this day and age it should be expected that these guys are going to have phones and maybe there's a way to work around it that isn't completely banning them. I also think it's important for kids to be able to talk to their parents during the school day of something is wrong. I know my son has texted me when he wasn't feeling well and a sub wouldn't let him call home. Or I know of a student that was able to text home about an unsafe situation they didn't feel comfortable going to the front office with.

I just think that it needs to be enforced more consistently. There are a few teachers that I am aware of who ask students to set aside their phones at the beginning of class, but most allow students to have their phones in class. Based on our family group chat, I know that my child is using his phone at times when he shouldn't be (he's supposed to be engaged in the class lesson instead of on his phone). In his case, it would be better if teachers just took his phone because he is not yet adept at self-regulation and the phone, with all its fun apps, is just too tempting.

I just wish that they had there phones for in case something bad happens they can call me. R I can call them because we r living in days that r so wrong .

I know that cell phones can be distracting, but in the three years my kids have been at West, there has been a lockdown, a stabbing, and both of my kids have been bullied. I want my kids to always have their phones nearby to reach me if there is a problem.

I know that some teachers require students to turn in their cell phones during class time and I support this fully. Students need to be rid of this distraction for learning.

I know the rules prohibit but somehow there is still exposure more than I feel comfortable

I know there is a policy in my daughter's classroom, but if there is a policy at the school level I am not sure what that policy is. Probably that should be cleared up for Ensign parents.

I know they're a huge distraction. Kids rely on them for updates but notifications and updates are also the biggest distractors for them. They also are too easily tempted with social media and taking and posting (even texting) decontextualized photos.

I know what the cell phone policy is that we have been trying to implement but currently, there isn't a school-wide policy. I wish there were one!

I know young kids are not appropriately monitored by their parents and there have been times when my son has been uncomfortable about some things he hears or sees from them.

I like being able to contact my child as since 9th grade theirs has been over five school lockdowns for various reasons including guns in the school Taking away this communication device scares me

I like that my kids can have their phones in case of an emergency.

We have made efforts to ensure that our kids are responsible with their usage of phones and that they know it is important to pay attention in class, and not be distracted by their phones. I will occasionally get a text from them during school, but only if it is something important.

I like to be able to maintain communication with my child, especially in an emergency. I would prefer to avoid a blanket policy and build a policy that is based on addressing problems if they occur.

I love it!

I LOVE that Clayton is so strict about having the kids put their phones away. I don't want my child or his peers on their phones all day and certainly not during class time. I'm a huge supporter of cell phone bans in school.

I love that they make the kids store the phones in a pouch away from them! I am also a classroom teacher and my school doesn't do anything like what the OC does. The consequences of our inaction at my school is that students constantly are distracted from learning what the teacher is trying to teach. We also have rampant cheating problems due to phones in light of the development of ChatGPT, etc.

I love the policy at Hillside.

I mostly agree with the policy. I would like my child to have her phone with her for emergency and afterschool transition to home communication. We are trying to foster independence and let her walk home. But we do worry about her safety and want to track her through her phone outside of the school.

I only text my child during the day when she asks to stay after for tutoring or if I need to know something important.

I rarely need to text her, but when I do it's usually for time-sensitive reasons. I appreciate being able to communicate on those occasions.

I rather it be much stricter and evenly enforced in every classroom. I think cell phones are doing mental harm and creating further social divides and bullying situations. I am more worried about cell phones than guns. Next question below is worded poorly. We communicate to Sadie maybe 1 x a week on her cell about after school activities. Not daily. Need that option because it's not "never" and it's not "daily"

I really don't think elementary school students should have cell phones at all.

I really liked the cellphone policy so that the student can focus on their class.

I send my son to school with his phone but only to be used for emergencies or after school I agree he shouldn't be using it during class. I do have concerns that if anyone sees it even though it's not in use they may feel the need to take it and justify doing so because of this policy

I strongly support a cell phone ban during class time. I think it's distracting for students and they don't have the skillset to be able to control it on their own. However, it has happened that a message does need to be shared with a student - pick up change, forgotten item dropped off, that can be handled faster and easier without bringing the office and runners into the classroom and creating more disruption. I want students socializing in person during lunch, but if my student could check a message without getting in trouble at that time it would be helpful.

I support the idea of students not taking phones to the class

I support the local school administrators to choose a policy that makes the most sense for the students and teachers at the school. I do not believe there is a "one-size fits all" policy and approach, and want to continue to see that decision being made by Principal Powell and her team in coordination with what they believe is best for learning.

I support the policy for the students to not access cell phones during school hours. If parents and students need to communicate, they can do so through the office.

I text my child while he's at school, but I don't expect a reply til school is over. (this comment is to explain how often I communicate with my student during the school day on his cell)

I think (know) that cell phones have had a disruptive effect on education. Social media is particularly destructive to mental health. I was getting an electrical engineering degree in the 90s when the graphical internet was rolled out. There was so much optimism. It has been depressing to see how it turned out.

I think cell phone (and watches) should not be allowed in schools. They are a distraction.

I think cell phone use policies should be left to teacher's discretion. I am concerned that one parent's insistence on a more specific cell phone policy will in turn require teachers to enforce yet another impossible disciplinary task. I fully support the SIC if they wish to tell Kristien McDonald to kindly quit with her continued pressure in pursing her private agenda.

I think cell phones should be banned completely and entirely from school campuses.

I think cell phones should be put away during class. With one to one devices, I see no reason for students to use cell phones.

I think is important that kids have access to their phone so they can call out in case of emergency. The founds

should only be used in the case of emergency.

I think it is far too restrictive and there should be a focus on teaching safe and appropriate use at school rather than an all or nothing approach as that isn't the case when they move to the high school in 2 years. Should be some gradual autonomy.

I think it needs to be tougher and evenly enforced throughout every classroom. The phone is a massive distraction and is more dangerous than guns when it comes to bullying and social divides. The next question is worded wrong. I maybe text Keegan about pickup changes 2 times/ month. I don't text daily.

I think it should be more strict. No phones at school - period.

I think it's important not to override a parents' wishes regarding communication devices. I support the school's desire to reduce distractions and understand the potential downsides of cellular devices in the classroom, but parents have a right to access their children 100% of the time without exception and that needs to be respected above all else.

I think kids should be allowed to at least wear and use (at times) their apple watches.

I think kids should be leaving their cell phones in a basket by the door. If there is an emergency, they will be able to retrieve them. No kids should be on cell phones in class

I think my child should always be allowed to have cell phone on them, but in silent mode in case there is a school emergency and they need to contact me ASAP.

I think Phone should be absolutely banned in elementary and middle schools. Terrible.

I think phones should be banned during class.

I think students should be able to wear their watches and keep them turned off. OR teachers have a basket where students put them in the morning, and then get them at the end of the day. I feel like this is safer than lockers/backpacks. Our nephew goes to another school in the district and they allow watches (off) and also use baskets.

I think students should have access to their cell phones. When the school notifies us that they are in lockdown, it really is great that we can contact our student to make sure he is okay.

I think students should put their cell phones away during class time because it is a distraction to themselves and others. They are on their phone too much!

I think teachers should require the students to put away their phones during instructional time. Cell phones can interfere with learning not just the students themselves but other students as well.

I think that cell phones should be forbidden during the school day and I think that none of the classes and activities should be linked to social media.

I think that students should be able to check their phones between classes to communicate with their families.

I think that students should be able to have cell phones in their backpacks in case of emergencies. I think that they should be completely put away during the school day (including lunch and recess) and that they should ask for permission before using them.

I think that students should not be able to access their phones during class unless it's necessary for completing an assignment. I like the plan of having students stash their phones in some kind of keeper for the duration of the class period. I also trust teachers to determine when phones are necessary and/or useful. I have 2 kids at the school. One does a good job of managing her own use, but the other will be on his phone 24/7 if there are not some parameters put into place. When I've asked my kids, they both say that it's not really a policy or that it's not enforced at all. They both have one teacher who insists that students stash their phones when coming into class. The other teachers might take a phone away now & then but don't really adhere to any consistent policy.

I think that the legislature is too involved with cell phones and access to them. It's imperative that students and parents have a way to communicate if needed. I understand not having cell phones out during instruction but to not have them at school or keep in their lockers is unrealistic!

I think that watches should be allowed. It's imperative to be able to track our children's location.

I think there could be a little more enforcement

I think there should be an absolute ban on cell phones at school.

I think they should be allowed. With a 504 my student needs to be able to get ahold of me. Plus a school shooting terrifies me.

I thought at the beginning of the year cell phones were not going to be allowed but then I sat in the first pta meeting and learned that the teachers wanted the students to have their cell phones because it made their jobs easier which is disappointing.

I trust this school to have policies they see fit in keeping all kids safe.

I understand it, although I do worry that if there was some kind of emergency that my kids wouldn't be able to communicate to the outside world or get ahold of us!

I understand that this past year the school banned cell phones during class time. I love that because especially in elementary school, there is no need for cell phones. I can't remember if they are banned all school day? I think it's reasonable to allow high schoolers to look at their phones between classes and at lunch, but I don't think elementary school kids need to bring cell phones to school or have access at all during the school day.

I understand the need to keep it off but they should be allowed to keep it on their person incase of emergency both at school and at home.

I want my child to have access to their cell phone during the day. I want them to be able to reach out to me. I don't really feel safe about the school.

I want my child to have his Gabb watch on at all times during school. For emergencies, etc. I will continue to have my child wear his watch until a completely safe environment is achieved.

I want my child to have their phone in case of emergency and or a school issue

I want my child to keep their cell

Phone on them at all times while at school

I want my daughter to be able to get ahold of me if there is an emergency

I want my son to have cellphone access while he is at school. This does not mean that I want him to be on his phone during class, but I do think that it is important for students to be able to contact a parent from their classroom in the event of the emergency. My older child attended West High and had two separate gun lock downs where students had brought a gun into the building. The first lockdown happened the first week of school during her sophomore year. The second incident happened right before winter break her senior year. That lockdown lasted for longer 4 hours, with students in their darkened classrooms. It was important that she be able to text me as she is highly anxious and was scared. At the same time, it is also important for students to be able to send an anonymous text through the SafeUT app to report if they see a gun at school or suspect that a classmate might be a threat to themselves or other students.

I want my son to have his Apple watch on at all times. If there's ever an emergency (earthquakes and school shootings come to mind first), then I want direct contact with him.

I want my student to have their phone with them for safety reasons but I don't want phones to be out and to be used in classes.

I want the abiilty to reach my children in an emergency once they have cell phones.

I want to make sure that teens are not showing each other pornography at school or cheating.

I was never told the cell phone policy

I will never have my daughter give up her phone. It is our communication and emergency connection while she's at school. AND it's a tool for learning. The policy is archaic and narrow minded. We are living in a world with new technology. Why would you take this away and have them know less than other students around the world. Stop focusing on taking away and more on giving them what they need to be successful. So stupid.

I will not allow my elementary student to have a phone and I believe phones are unnecessary in the classroom in all grades.

I will prefer that the cells were not allow anytime at school

I wish Dilworth's policy was as strict as Hillside's! I think it's ridiculous for any elementary students to even own cell phones, but that's just me. I know other parents disagree. I believe most parents agree that cell

phones shouldn't be out/in use at school.

I wish the lockers had locks for my daughter to safely leave her phone in the locker during class.

I won't be giving my child a smart phone and fully support banning them completely at school.

I work full time with a schedule that can be unpredictable. It is a real inconvenience and has been a safety issue for her not to be allowed to check her phone during passing periods and lunch. I agree phone should not be used in class

I worry about emergencies -- not feeling well, headaches, feeling unsafe -- and the kids are not allowed to use the phones. I think there needs to be a little leniency.

I would appreciate a no cell phone policy.

I would be concerned that students are focused on their phones and what they can do with them at school, versus actually learning.

I would just need to be sure to be able to get hold of my child in case of an emergency or coordination that affects them leaving school early, etc. I understand that I can call the office but there is sometimes a long delay in when the "runner" can deliver the excuse note to the class to get my child.

I would like cell phones to be banned while in school.... And I know this is impossible.

I would like for cell phones to be disallowed at all SLC schools

I would like for cell phones to be disallowed. There are numerous studies documenting the deleterious social and cognitive effects of phones at school. Please reconsider the policies.

I would like it to be even more strict. No phones allowed at all!

I would like my children to be able to wear a device so that if something happened where they were on lockdown in the school or some time of emergency were to happen my children could contact me. Bonneville does not allow my kids to wear a watch so they can contact me.

I would like my daughter to have her phone all the time just in case. Due to the way the world is.

I would like my son to be able to have his phone at school in case of an emergency. I do not want him to use his phone during class time but after school or lunch time should be ok.

I would like my student to have access to a cell phone during lunch and after school to communicate with me regarding pick-up etc. or to be able to use it if excused to step out of a class to communicate with me that she's forgotten something etc. and certainly to be able to communicate if there is some emergency either personal or at the school generally. I would be supportive of a phones off during class policy and o.k. if it meant taking the phones away at the beginning of each class. Related to this I did some homework as to what the cost would be to get fiber to the school and offered to personally work to raise funds to install said fiber and after two requests to have school IT personnel &/or the principal call me to discuss this I've heard nothing. So very frustrating!

The weird thing is, I actually really never had contact with her during the day. I think it just gave her comfort knowing she could get ahold of me.

The current phone policy stifles learning and disrupts communication. Phones can be educational tools, offering dictionaries, translators, and instant access to knowledge. A confiscated phone leaves a student stranded without these resources. Banning phones also hinders communication with parents or guardians in emergencies or schedule changes. Trust and open dialogue, not blanket bans, create a responsible phone environment.

The fact that we don't get to have it out like what is the point of trying to make school fun when you already took away backs packs, mirrors, and etc cause now its jus a private school it is not no public school no more and it makes people have problems with the teachers to not just students. It is not a problem to our learning

because sometimes we just need a break were not jus staring at it forever. It doesn't effect our learning it actually shows that students should get there work done to go on there phone and have free time

the kids should only answer their phones if it is a emergency

TEACHERS

Admin is made an announcement during an assembly that it was okay for students to have them "out of sight", which students took as it was okay to use. This was AWFUL! The policy states (and that's what parents and students signed) that cell phones will be in their lockers, and that's what I hold my students to, so needless to say I got lots of student backlash after that assembly when I'd take a phone.

Application of the cell phone policy is inconsistent and hard to enforce because of the inconsistencies. In addition, many students use cell phones to help them with school (to take a picture of the board and use the picture to take notes, for example). I'd like to offer better options to students who are using the phones for class aid (I could make a copy of the notes for the table, etc), but it doesn't feel worth the effort when so many students are using the devices in different ways and we don't seem to have a cohesive solution as a school. We also have many students who say they are communicating with their parents in class. While this may not always be true, we need to address parents as well in considering the cell phone policy.

Because it is not universally adopted or enforced, it requires too much energy to be the teacher has this expectation. When I remind students that using a device during class is a violation of a school policy, they seem unaware of this.

Cell phones and/or cell watches should not be the teacher or schools responsibility whatsoever. Students should not have access to cellular communication unless a part of an IEP, 504 or if a safety issue is agreed upon by the Administration, faculty and parents.

Cell phones can help students who need a tool to manage time, complete and turn in work, quickly look up grades in Power School and receive alerts from Canvas. Cell phones can be great learning support tools, but we do not teach how to use them effectively or ethically which leads to problems later on. We would be wise to implement better phone use policies, then support and monitor them.

Cell phones policies shouldnt be to ban. We need to educate how to use these devices to support education.

Cell phones should not be allowed.

Classroom or district policy only.

Consistency with the policy of having phones in lockers and not in binders or pockets.

Creating and implementing a cell phone policy for individual schools is almost impossible without support from the District Level.

It is impossible for teachers to oversee any cell phone policy without extensive help from above (administration and district level support).

Policies are easy to create, but enforcing them, with real consequences is the challenge.

Difficulty of enforcement

District's cell phone policy lacks any tangible enforcement, so I would say it is generally ignored by both students and faculty. Students have learned there is no actual consequence for inappropriate phone use, and faculty has no district support in enforcing any policies, so we just do the best we can. Reaching out to parents / guardians is somewhat effective, sometimes.

How well it is backed

I agree with the cell phone policy but it is not inforced.

I agree with the policy, but it is not followed.

I am concerned about cyberbullying but I trust our school community to handle it.

I am the bad guy to the parents when implementing this.

I am very supportive of Clayton's cell phone policy. We led out on this before most schools, and it has been very effective in reducing drama and cyberbullying.

I believe that we should be teaching students how and when to use digital devices as tools at school for learning. I think it is important for students to put personal devices away during instruction time and elementary students should be supervised when using phones during school hours. I do feel like phones have become a family life line with the gun violence threats in our country and as a parent I would want my child to be able to contact me in case of an emergency. It would be nice to see more instruction and higher expectation around digital citizenship.

I can only control the policy inside my room. My students know that I will enforce the policy and phones are not an issue in my classroom. I think that some staff (paras in particular) do not feel empowered to take phones from students. Students do not always listen to them.

I do not feel that the policy has any force and is fraught with potential liability problems if a teacher were to attempt to enforce it. In my opinion all schools should be phone free. When students have access to a computer there is no need for them to use a cell phone. Please implement a system that eliminates student cell phones in school. "Yonder" or similar.

I do not have any concerns with the policy. Students put their cell phones in a lock box when they enter my room in the morning and pick them up at the end of the day.

I do not have many concerns about Cell phone usage in elementary grade. I agree with not allowing them in the classroom, but understand the need for them before or after school.

I don't have concerns at this time, but do think it's important for us to be consistent and on the same page.

I feel students should only be allowed on their personal cell phones for emergency situations or emergency family need.

I feel, at the elementary level, there should be no cell phones in the classroom or in student lockers. They should be checked in at the office daily and parents need to contact their children through the office.

I fell that students should not have phones on them during instructional periods.

I have no concerns as we are working the details as the culture has shifted.

I love our no cell phone policy, and it seems to be effective. The only concern would be whether all teachers are enforcing it - it is important that all are on the same page.

I love the policy because it helps reduce distractions at school. I do wish however we teach appropriate and healthy use of technology (limiting hours of screen time, using technology to help your complete assignments not do your assignments

I personally don't allow phones in my classroom. Setting this precedent from the beginning of the year has made it a (mostly) non-issue. Elsewhere in the school, and OUTSIDE of school (distracting from homework, etc.), it is a persistent issue, in my opinion.

I refuse to touch/take a students property.

I teach Kindergarten so we do not have cell phones.

I think a stronger 'no cell phone use' policy would be of great use to the students, many of which are addicted to phones and distracted by them during class time.

If a rule was school wide AND ENFORCED by ALL teachers, it would be the norm and wouldn't be a big issue, I believe.

I think it could be stricter

I think students should not be allowed to bring them to school or at least have them stored away at the office. Cell phones usually contribute to unsafe learning environments.

I think students should not use them at school. I am so glad we have banned phone use at school.

I think the extent of our cell phone policy (e.g. it can't even be on; it can't be in your pocket; as soon as you walk in the school door, it's off) is the reason why so many kids break it. It feels unjustified to them so they are less likely to be compliant.

I think we need to ban cellphones at a district level. I can't teach at all without fighting students for their cellphones all day.

I think we need to teach students how and when to use them appropriately. Banning phones doesn't help students learn the control they need as they get older.

I wish there were clearer directions for implementation and a more unified agreement among staff of adherence to the policy.

I wish we could do an all-out-ban on them.

I wish we had a procedure at our school that gave support to teachers trying to keep cell phones AND headhpones out of their classroom. I know that implementation of strict cell phone procedures would require a significant amount of administrative/front office back up and help and I worry that this would be impossible

given all of the work already done by these groups. I know that parents in our community are pushing for a more strict ban, but I worry that we simply don't have the manpower/infrastructure to implement that along with all of the other policies we need to carry out to keep our school safe.

I would be in favor of a complete ban

I would like a zero tolerance policy, no phones allowed for all grades especially during passing periods and lunch. More than that, I'd like a no headphones/earbuds/airpods policy. Thats almost more disruptive than phones.

I would like it to be stricter.

I would like to have cell phones removed from the classroom, but I also think it needs to have parental support. If we could ban them all together, then we would have a policy for all classrooms and wouldn't have pushback when they were taken away

I would love for the administration to support teachers more: allow the teachers to take a student's cellphone to the office for the parents or students to collect later.

I would prefer that they are not used at all.

I would support a total ban on cell phones in class.

I'd like to see our cell phone policy to go back to no cell phones in classrooms at all (all phones in lockers).

If a school shooter were to enter the building and a student or a teacher's phone where to peep, there would be a problem.

If students do not have a laptop, I would rather they use their cell phone, than to sit there and not participate.

If we have a concern with a student using a phone and it is becoming an issue I am not aware of what support our administration will give us and if we will be supported by the admin. It feels like it is an issue no one wants to discuss or give direction on ho9w to handle it.

Im concerned with confiscating personal property of a student or parent, and I strongly agree that cell phone policies should be uniform across the district, starting with High Schools and then down through elementary schools.

I'm not sure there's a real, standardized solution to the cell phone issues at school until we can get parental support for a policy. I'm not sure the parents are aware of how devastating the cell phone problem can be at school, so that might be a good first step to help them get on board.

In elementary school, there isn't a safe place to store phones (lockers don't have locks).

In elementary school, this is not really a concern. Maybe for upper elementary, but not for lower elementary. Where I see an issue that should be addressed is that there are medical reasons for students needing their phones. I am a type 1 diabetic and how I manage my disease is through my cell phone. It must be on my person at all times. If a student has Type 1 diabetes, they too will need to manage their disease with their phone.

Interruption and unable to stay focused with learning.

It doesn't acknowledge the reality that we all use phones throughout the day.

It is a great policy in theory, but utterly in enforced or enforceable! There is no support or structure for enforcement of this policy

It is not enforced and becomes an individual teacher problem.

It is not enforced in a consistent way even though we have gone over the policy several times. Upper grade students seem to be allowed to use phones in ways that are against the policy.

It is not enforced, followed, & consistent!

I prefer NO cell phones in school period.

Drop them off as you come to school and have true immediate consequences.

It is not enforced.

It is not universally enforced, which makes it hard to stick to in my classroom

It is unrealistic and doesn't address principle causes.

It needs to be enforced all the time.

It needs to be stronger. The school board should make a policy that schools could stand by and enforce.

It should not be the teachers responsibility to monitor cell phones.

It's only loosely enforced

It's time for a district-wide cell phone restriction. Please help your teachers. This is no longer a game, and the students are suffering because there are no hard rules.

It's too loose, but we have plans to change that for next year.

It's up to individual teachers, so it varies from classroom to classroom.

Kindergarteners usually do not have phones

Lack of enforcement school-wide.

Lack of Policy

Most teachers don't enforce and student's don't follow.

My only concern is that it needs to be implemented with higher levels of fidelity. There's been a drastic increase in cell phone use because we were too relaxed with enforcement this year.

My students are in preschool. We do not use our phones.

Needs to have a ban on cell phones. We are still struggling with cell phone use in the school

No concerns.

No policing of middle schoolers during lunch

No school that I have worked at has had a true cell phone policy. It's always up to the teacher. Suggesting that we have them use lap tops instead is not a policy.

None, I think cell phone use in the classroom should be at the behest of the teacher and they should have those guidelines noted in their disclosures.

None. It's clear cut and helpful

Not all teachers are making students follow the new cell phone police.

Not all teachers enforce it equally, students sometimes keep cellphones in pockets which is impossible to know about since we don't search students.

Not all teachers enforce the expectation of no phones and no ear buds from 7:40 to 2:30 which makes it more difficult for those of us that do.

Not appropriate for classrooms.

Not everyone enforces as they should and it causes confusion.

One of the reasons I want to teach at Clayton is because of its ethical and reasonable cell phone policy. I frankly find it immoral and borderline abuse (at best neglect) for any schools (and parents) who do not have similar cell phone policies that prioritize the growth and mental wellbeing of their child over enabling addiction and short sighted self gratification through permissive cell phone policies.

Our cell phone policy is actually a technology policy as it covers all Smart devices, not just phones. We have issues with parents who feel that their children should be granted exceptions. This can be a very slipperly slope, because word gets around, and once one family is given an exception, lots of other families want one and pretty soon, we don't have an effective tech policy anymore!

Overall, I think we do a pretty job (better than most schools) but we could probably do better. Some kind of system for consistent cell phone enforcement would probably be helpful.

Parents call/text students while they are in class. Parents can be a bigger problem than the students in that regard.

Parents contact their kids through their cell phones while they are in class.

I wish the district's policy had more teeth, it is a constant drain on my energy monitoring cell phones even though I have a policy of no personal cell phone use during class.

parents need to be at the forefront of understanding the impact that cell phones have on their students. I believe parents are abdicating their authority with cell phone use at schools. They are placing way too much responsibility on teachers to manage such a personal and expensive item which has primarily been a purchase by parents.

Please implement a school wide no phone policy

Policies only work if they are communicated clearly to all parents, students, and staff and if they are enforced consistently and equitably. At present none of the above are true of the school's cell phone policy as it pertains to East High.

School needs to have clearer expectations for students to bring charged laptops every day, and/or more laptops available for students so that cell phones do not become a substitute for laptops when students need to access Canvas, which has become the main way that teachers provide instructional materials and do grading at our school.

Some teachers are allowing phones to be used in the classroom. Every teacher must follow the school's policy.

Sometimes, students do not have their computer and the assignments are on Canvas. In that case, students need access to their computers.

Stronger enforcement and schoolwide enforcement

Students and Parents need to be held accountable with their own personal property not teachers or schools. Admin and parents are not consistent with the current policy, additional policy won't make a difference.

Students are getting more relaxed and sneakily going to their phones here and there. Also, very likely when they are going to bathrooms during class.

Students are starting to get lazy about the rule and we need to reach out to parents again and make sure they are behind us again with the rule.

Students are still seen with phones. I'm not sure that they fully understand the policy.

Students do NOT need a cell phone on their person during school hours. If a parent needs to reach out to their child they can call the office.

Students lockers and no backpacks in class need to be prioritized to really solidify this policy.

students still use phones before and after school in halls and on school grounds many students have i watches

Students still use them in the bathroom throughout the day.

Teachers are not allowed to give any meaningful consequences for cellphone use during class (aside from taking the phone). In my disclosure, I tell parents I take the phone for the whole day. I have students text their parents to let them know I have the phone. I have NEVER had a parent disagree with me taking the phone the whole day. Because of my classroom policy (that goes against district policy), I don't have cellphone problems in my class. If I take the phone three times, the guardian listed on PowerSchool must come and pick it up. Once again, I NEVER get anything but, "Thank you" from parents. I realize that my policy does not align with the district, but it works. The minute I have a complaint from a parent, I will rethink it. Of course, I allow for special circumstances.

That it is hard to enforce. If one teacher goes easy on it, it makes it impossible for the other teachers to crack down. all teachers need to do the hard work of enforcing it.

The cell phone policy is not enforced.

The cell phone policy is not working nor has it been enforced. Cell phones need to be taken however they are not. Nothing works. I am not the police either so I do not think it my job to police if someone has a cell phone on them. I think we need to teach students the correct time to use them and how to use them correctly.

The fact that so many young students have phones and are not responsible with them.

The only concern I have with cell phones is that we need towers so that we have cell service in our building. It's a concern especially in case of an emergency.

The policy is still inconsistent for students, as it depends on the teacher/class and what the teacher is willing to tolerate. It's not stated in the policy as written, but I do not think students should be excused from class while carrying their phone, as they have a tendency to use the phone to coordinate with their friends to also get excused at the same time, leading to more time spent out of class. Phones should be on campus for emergencies only and otherwise turned off all day. It's a fact that we could never police 1300 students and their phone use, so it makes sense to focus our efforts explicitly for the learning environment (classrooms).

The policy needs to address smart watches used by younger children.

The policy to keep cell phones away is reasonable given the addictive nature of cell phones, the equity issues around not every student having one, and the ability for all students to access laptops in the school. The consequences seem punitive and rigid. I would prefer to have more flexibility in how to respond to cell phone misuse.

There are no consequences school wide for student cell phone use in the classroom.

There aren't many measures to help teachers reinforce the cell phone policy. I can tell students school policy says _____ but there is little I can do if they don't actually listen without becoming a micromanager of their behaviors.

There is a lack of policy implementation. Each teacher applies whatever they want within their classroom. The policy should be talked about in staff meeting and administration should reinforce the policy.

There is a lot of vetting that needs to be done.

Cell phones are not "evil".

Klds need to be taught appropriate use. Teachers need parental support to take kid's phones.

Parents need to be educated on how to put locks and restrictions on thier kids's phones.

There is inconsistency in the policy and who gets support from admin when an educator enforces the policy. Black teachers are met with vitriol, while white teachers are supported by admin.

There is no cell phone policy. Students carry their cell phones around. I take my students' cell phone before the class starts each day.

There is no support from admin on this policy. The policy is not implemented by everyone across the school and it holds no real consequences for students.

There is teeth, lack of cohesive response, creates a constant fight with students

There isn't enough being done to create a sense of uniformity across all classrooms in the school in regards to the cell phone policy. Students that do not abide by the policy often times are not ever being penalized or know how to circumvent the policy and know how much usage they can get away with. I believe there is a direct correlation between poor performance in class and heavy usage of cell phones for non-educational purposes.

There isn't one.

There should be something included about smart watches. Parents text students throughout the day which disrupts their learning.

This is not applicable to me, due to the age of my students.

This policy has put an additional burden on teachers. Any policy that puts enforcement in the hands of teachers runs the risk of backsliding the work we do to build rapport with students.

This policy is not being implemented consistently. There are no real consequences for not following the policy, This year we were not as strict about students having cell phones on their person, this has lead to more issues with students trying to use their phones or having earbuds in. Next year I would like to see us go back to being more strict about no cell phones on students whether they are using them or not.

Uneven in how it is applied by teachers.

We are in the process of fine-tuning our policy... My only concerns for the future of the policy are making sure that the whole staff is consistent and equitable when implementing the policy and corresponding consequences.

We did great last year. However, this year we have laxed a bit. We don't allow students to use them in class at all. And yet, we have teachers that still do go against the policy. It's a good policy when we all follow through.

We do not have a strong, unified cell phone policy.

We don't have a specific one, but defer to the district policy. It is impossible to control cell phones in my classroom when other teachers allow them. What is the bigger issue, is the ear buds. This is what needs to be banned. I can have a place for their phones, I can easily see them out. Students constantly want to change their music or listen to music etc etc. THEY ARE A HUGE PROBLEM. When students don't bring their computers, or they aren't charged, accessing the material on their phone is the only solution. Unless I plan two lessons one digital and one paper based, and that is not going to happen.

We have a great policy, but as per usual, the follow through for staff and students has been lackluster. It was not implemented in a way that all staff members knew the correct consequences for all students and as such, the policy was inconsistently applied based on which staff member was intervening.

We need a strict no cell phones in class policy. Our current cell phone policy is unmanagable because so much class time is spent reminding students to put their phones away. The only way this will change is if we don't allow phones in class. We have computers that the students can use for learning activities. Cell phones are too

much of a distraction. It must be a whole school policy to be effective.

We should have a lower tolerance for using phones in school.

We won't please everyone with any policy and the loudest, angriest behavior seems to get their way.

What to do about watches. More and more students are texting on them. Maybe we need to have the same policy for them... in backpacks or lockers, not out during the day.

While I disagree with cell phones being available to students in class for non-academic (personal)use, I find that they are almost indespensible for submitting work on Canvas when the student's laptops are forgotten or not charged.

Who is and what is going to happen to enforce the policy? Who and what will support teachers so that we are not spending significant time during classes trying to enforce the policy?

Would like to consider being able to use phones for some curricular activities that are specific to a class or teacher's need.
