SCHOOL BOARD MEETING – Special Zoom Meeting

January 3, 2023

The Special meeting was called to order by Board Chair Jason Louwagie at 7:01 a.m.

Board members present: Jason M. Louwagie, Vicki Myers, Korey Herrick, Dan Louwagie, Tracy Sterner, Joel Timm, and Al Grube. Also present was Superintendent Chris Fenske.

It was moved by Grube and seconded by Herrick to approve the Consent Agenda which included the following:

1. Designate Official School Newspaper as Tri-County News (Cottonwood)
2. Designate Ratwik, Roszak, & Maloney as Legal Counsel for the School District for the 2023 Calendar Year.
3. Establish First Independent Bank of Cottonwood and First Independent Bank of Wood Lake as the Official School District Depositories & Requiring Said Depositories to Provide Letters of Pledged Collateral in an Amount Sufficient to Cover School District Business.
4. Authorize Superintendent and/or Finance Officer to Invest in Passbook Savings, Money-Market Savings, CD's, MDSLAF, & Other Legal Investments as Recommended for School District Funds as Needed for the Operation of School District Business.

Motion carried unanimously by roll call vote with the following board members voting yes:

It was moved by Herrick and seconded by Timm to approve a motion establishing 2023 Per Diem Rates for the School Board Members. Per Diem Rates are \$50 per meeting and \$20 per hour for over 3 hours for daytime meetings. The Clerk receives a stipend of \$250 and the Chair receives a stipend of \$500.
