Bonham Middle School Parent and Family Engagement Policy ESSA Section 1116 2022-2023

1. - Timely information will be provided to parents in the following ways: school website, social media, letters home, email, SchoolStatus, and phone calls in English and Spanish
- Keeping open two-way communication through email and phone, conferences, meetings, parent portal, Schoology, school status, school website, social media, and letters home in English and Spanish
- Parent workshops will be held to help better understand the curriculum being taught in the classrooms as well as programs through email and phone, conferences, meetings, parent portal, Schoology, school status, school website, social media, and letters home in English and Spanish
 - 6. If the schoolwide program plan (Campus Improvement Plan, CIP) under section 1114(b) is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency. Section 1116 (c)(5)

If the parents have negative comments, give the comments to the principal who will present them to the LEA office. A survey will be distributed in October through Google.
