Communities in Schools (CIS) Presentation - Human Trafficking

CIS reviewed the "Not A Number" curriculum which is a child trafficking and exploitation prevention curriculum from Love146. Curriculum is developed for ages 12-18 and is gender inclusive, it's intended to be taught in groups of 5-30 students in approximately five 50-minutes

sessions, but can be delivered in as few as four sessions. The program is trauma informed with a student-driven approach that's collaborative and interactive, and encourages peer-to-peer prevention.

Standard Program Design Includes the following 5 Modules:

- 1. An Introduction to Human Trafficking and Exploitation
- 2. Society and Culture
- 3. Red Flags and Relationships
- 4. Vulnerability and Resilience
- 5. Reducing Risky Behavior and Getting Help

Program includes a pre and post survey and a pamphlet of local community resources for participants.

SHAC Recommendations

SHAC acknowledges that the "Not A Number" program requires a significant time commitment and deliberated on how best to deliver this subject matter to the students in ECISD. Ultimately, the committee recommended the following:

- Adapt "Not A Number" program to 4 days
- Give campuses the flexibility to pick a week for this curriculum, and deliver it in one of the core classes each of the 4 days
- Grade Level Recommendation TBD SHAC will review statistics on which age group/grade level is most impacted by the subject matter locally to determine the appropriate grade level for curriculum delivery
- · Maintain current training for ECISD staff on subject matter as is
- Develop a mid-to-long term plan to train ECISD campus staff that already works with high risk youth as instructors of the "Not a Number" curriculum

SHAC unanimously approved the above-mentioned recommendations to deliver Sex and Human Trafficking Curriculum in ECISD. Sara Hinshaw made a motion to approve; Dawn Weaks seconded the motion.
