
#### Cecil County Elects New Board Members;

#### Testing News to Celebrate!

- All Time Best math scores were achieved in grades 3-7 and grade 8 scores improved on the Maryland School Assessment (MSA).
- Grades 5, 6, and 8 reached All Time Best scores on the reading portion of the test with an increase in scores seen in grades 3 and 4.
- 100% of seniors who fulfilled all other academic requirements for graduation met the High School Assessment (HSA) requirements for the second consecutive year.
- Three out of five high schools experienced a decrease in dropout rates between 2009 and 2010 resulting in a decline for the county from 3.49 to 3.4.

#### What is "AYP"?

In accordance with the No Child Left Behind legislation of 2001, the reading and math performance of students in grades 3-8, Algebra, and 10th grade English is measured and reported annually. Schools across the entire country work toward achieving the federal target of 100% of students proficient in these subjects by the year 2014. Annual benchmarks are set by each state providing a standard against which schools and school districts must make Adequate Yearly Progress, known in all schools as "AYP."

Nicole Morris-Stauffer










### 2009-2010 HIGHLIGHTS

# CAPITAL IMPROVEMENT PROJECTS & FACILITY UPDATES



#### Calvert Elementary School

Construction is nearing completion at Calvert Elementary. All K-5 classrooms have been completed and are in use. The new office and lobby provide better security to the building. The final phase of construction includes a new media center and art room, as well as other support spaces. Work in the building will be complete in January 2011. Remaining site work will be completed in the spring of 2011.

#### Leeds Elementary School

An HVAC project was completed at the school which improved temperature and humidity control throughout the building. This project also added air conditioning to corridors which did not previously have it. Ceilings were replaced through much of the school and new lighting was provided in classrooms and the media center. Additionally, ADA accessible restrooms and an expanded health suite were completed as part of this project.

#### Elkton High School Stadium

A rededication of the Elkton High School Stadium was held at the first home football game of the 2010 school year. This event celebrated upgrades which included new bleachers and a press box, renovations to the existing field house, and an addition of a new building for public restrooms and a visiting team locker room.



## Schools Earn "Superior" Facility Rating

Cecil County Public Schools is pleased to announce that Cecilton, Holly Hall, and Leeds Elementary Schools received a "Superior" rating from the Maryland Public School Construction Program regarding their facility's appearance and cleanliness. CCPS has received eighteen "Superior" ratings in the past thirteen years. Past award recipients were Cherry Hill Middle. Bohemia Manor Middle, Rising Sun Middle, Calvert Elementary, Cecil Manor Elementary, Cecilton Elementary, Kenmore Elementary, North East Elementary, Bay View Elementary, Rising Sun High School, Bainbridge Elementary, Conowingo Elementary, Rising Sun Elementary, Elkton Middle, and Charlestown Elementary School.

## SCHOOL SYSTEM FUNDING

Cecil County Public Schools, like all school systems in Maryland, is fiscally dependent. This means that the school system has no direct taxing authority. All revenues necessary to prepare schools for students, pay our teachers and employees, and purchase the supplies and services to deliver instructional services to each of our students are received

from Cecil County government, the State of Maryland, and the federal government. Miscellaneous revenues are received from other sources, such as investment earnings, nonresident and summer school tuitions, and rental facilities.

The State of Maryland revenue represented 56.6 percent of FY '10 revenue. These funds included the foundation funding formula, transportation and special education formulas, and maintenance of schools. In addition, the state's contribution to the State Retirement and Pension System for eligible employees is reflected in this revenue.

In FY '10, 6.7 percent of revenue was received from the federal government in the form of grants targeted for use in specific areas. The major federal revenue received in FY'10 included: Title I, Title II Teacher Quality, Special Education, Perkins Vocational and Technical Education, Safe and Drug-Free Schools, and Technology Literacy.

Other revenue sources included investment earnings, nonresident and summer school tuition, insurance recoveries, etc., and represented 1.3 percent of total revenues.

Cecil County government's appropriation to the school system was 35.4 percent of the school system's receipts and represents 42 percent of the county's total operating expenditures for FY'10. This funding was provided to the school system from the local government's tax revenues that included two primary sources- property tax and income tax.

The Business and Education Partnership Advisory Council (BEPAC) is a 501c(3) organization in partnership with the Cecil County Public Schools. BEPAC members serve on advisory committees, participate in the speaker's bureau, and most recently provided engineering expertise as mentors for the Project Lead the Way (PLTW) pre-engineering and Science, Technology, Engineering, and Mathematics (STEM) Academy student canestone projects, and 5th grade Science, Mathematics, Imagington, Learning, Event (SMILE)



student capstone projects, and 5th grade Science, Mathematics, Imagination, Learning, Event (SMILE) at Gilpin Manor Elementary. The junior and senior students in the STEM Academies rallied around the 53 scientists, engineers and college representatives during our first ever STEM Rally Mentor Mixer. Through business and school interaction, students learn about job market needs and the skills necessary to be successful in the 21st Century workforce. BEPAC continues to collaborate with the Maryland Business Roundtable in providing classroom lessons that emphasize to students that "... what they do in school matters" and will continue support with the new initiative STEM.Net.

BEPAC welcomed seven new members and recognized five new school business partners. The 72 members have pledged continued support in expanding school partnerships, retention and recognition of teachers, mentors for the middle school AIM High program, middle school career exploration, advisors for all Career and Technology Education (CTE) and STEM programs.

BEPAC membership meetings are held on the fourth Tuesday of every month in the Board Room at the Carver Education Leadership Center, 7:30-9:00 a.m. Meetings are open to the public. For additional information please visit the BEPAC website at www.bepac.org or call the BEPAC Office at 410.996.5453
