#### 5.1 Review of BUUSD Policy Manual Index

A copy of the BUUSD Policy Manual Index (dated 1/9/2024) was distributed.

Ms. Parker advised that the document continues to be updated procedurally and with VSBA updates.

#### **5.2 VSBA Policy Notes**

A document titled 'VSBA Policy Notes – BUUSD Policy Committee' was distributed.

Ms. Parker advised regarding the notes which provide information regarding VSBA updates for the policies being discussed this evening.

#### 5.3 Title I, Part A Parent and Family Engagement Policy (E1)

Copies of the District and VSBA policies were distributed.

Ms. Parker advised regarding recent VSBA updates was done to assure alignment with Federal requirements and reiterated the need for the district to spend time reviewing the policy. Mr. Hennessey and Mrs. Fredericks shared context on some of the work being done on this policy. Very detailed policy that's still a work in progress. Mr. Kelly questioned Title I being for certain categories of people or everyone. Mrs. Fredericks confirmed it focuses on certain stakeholders but everyone else can benefit. Ms. Parker questioned if Title I is a grant funding stream based on certain demographics and you get a certain amount of funding as a Title I school. Mr, Hennessey and Mrs. Fredericks added you get more depending on the needs of the community. Title I is Federal monies. Use to be only Barre City benefitted, now all schools benefit due to a waiver which allows us to create investments for Barre Town. One middle school and one elementary school would allow even more funding. Ms. Parker questioned as we're doing different things like planning these

events that hit some of these highlighted things in the packet is this something you are filling in this document or what's the plan moving forward to get stuff in all these. Mr. Hennessey shared it's a full group admin team effort. Return this policy back to the parking lot and review again later in the spring 2024.

#### 5.4 Employee Unlawful Harassment Policy (B5)

Copies of the District and VSBA policies were distributed.

Ms. Parker advised we have a policy B5 in place adopted in 2021 and that VSBA Policy Notes talks about how they know they had already, not so long ago, reviewed and revised this but new changes in the law happened in 2023 and new definitions based on those laws to keep things consistent and that's why it's coming back. Mr. Hennessey recommended leaving the Administrative Procedures section out and continuing to list these as procedures in employee handbooks.

On a motion by Ms. Reynolds, seconded by Ms. Parker, the Committee voted 2 to 1 to send Policy B5, as amended, to the Board for First Reading with Administrative Procedures separated out.

Ms. Parker and Ms. Reynolds voted for the motion. Mr. Kelly voted against the motion.

# Pending policies in the parking lot (future Agenda items)

F3 - (Options-Based Response to Violent Intruder Drills, Fire Drills and Emergency Preparedness) The Agency of Education issued <u>Updated Guidance Regarding Egress</u> Evacuation and Options Based Response Drills for the 2023-2024 Academic Year on October 10, 2023 in response to the feedback they received from stakeholders indicating a need for additional clarity on the requirements for Emergency Egress ("fire" drills) versus Options-Based Response to Violent Intruder Drills. As a result, we have revised the VSBA model policy on Fire and Emergency Preparedness Drills (F3) to align with the updated guidance. Our revisions include changes to the name of the policy, language alignment, and formatting changes to distinguish requirements for options-based response to violent intruder drills from the requirements for fire drills. The model policy is now the Options-Based Response to Violent Intruder Drills, Fire Drills and Emergency Preparedness policy and it replaces the Fire and Emergency Preparedness policy that we issued on June 1, 2023. The policy code, F3, remains the same. If you adopted the VSBA model policy F3 over the summer or earlier this fall, you have already satisfied the statutory requirement that all school boards adopt a policy mandating biannual options-based response drills and fire drills by August 1, 2023. This revised policy can be adopted when it works best for your board - immediately or when you are warning other policies for adoption. Please visit our model policy manual on the website for the most up-to-date versions of our model policies, and reach out to Cara Zimmerman, VSBA Director or Policy Services and Legislative Affairs, with any questions.

F24 Prevention of Conflict of Interest in Procurement - formatting changes.

**F26 Security Cameras -** formatting changes; added two new paragraphs under Administrative Responsibilities: #8 specifies where security cameras are/not allowed; and #11

**D20 Curriculum Development and Coordination -** formatting changes; new implementation section that clearly delineates the roles and responsibilities of the SU board and the superintendent.

**D21 Educational Support Systems -** updated the policy to reflect changes in state law.

#### D3 Responsible Computer, Network & Internet Use

We have reviewed and reissued the VSBA model policy on Responsible Computer, Network & Internet Use (D3). This is a required policy and can be found in our online model policy manual. As a required policy, we recommend adopting the policy as written and consulting with your district attorney if you want to make any changes. Revisions include the following:

- 1. a new policy section
- 2. formatting changes

- 3. changes to the parameters for the access control procedures, specifically the list of what is considered "inappropriate matter" so that the language in the policy conforms to federal law and regulation
- added a sentence under the Limitation/Disclaimer of Liability section to clarify that the duties imposed on the district by the policy do not make the district responsible for the conduct of its users
- 5. added a sentence under the Enforcement section to include any conduct that separately violates District policies

**F20** (recommended) Fiscal Management and General Financial Accountability - incorporated F21 (Financial Reports and Statements)(now under #10 in F20); with input from the Vermont Association of School Business Officials (VASBO), we modernized the policy to include updates to the bond law and aligned the policy with best practices for managing district finances post-Act 46; we also reference the Vermont AOE Handbook for Financial and Accounting for Vermont School Systems (Handbook II) - Vermont law (16 V.S.A. §242(4) (B) & (C)) requires LEAs to follow the definitions, instructions, and procedures as presented in the Handbook II

**F23** (recommended) Capitalization of Assets - with input from VASBO and the AOE, we re-wrote the policy statement, added a new definitions section and defined capital assets and estimated useful life; added an option for districts to group assets that are acquired at the same time but do not meet the threshold for capitalization individually (e.g. library books)

## The following are pending from FY23 - Need to be finalized.

F27 (Communicable Disease Mitigation Measures for Students and Staff): replaces F33 (HIV Policy) - No notes from VSBA

**D1** (Proficiency Based Learning) (Required - Pulled from Parking Lot) - Included in the packet is the Original, Edited, and VSBA versions. Original appears to have been adjusted to fit the BUUSD district which requires a lot of edits if moving to VSBA version.

**E1 (Title I, Part A: Parent and Family Engagement)** Sandra Cameron (VSBA) advised that the work performed (by the AOE and VSBA) on this policy was done to assure alignment with Federal requirements and reiterated the need for the District to spend time reviewing the policy.
