BOARD ACTION

To address the identified District facility additions, repairs, renovations, and costs, on February 14, 2023 the School Board Voted to Approve an Order calling a Bond Election in the total amount of:

\$120,000,000

How will the District pay for the \$120,000,000 in new bond money?

The Bonds will be paid from Local Property Taxes (I&S), specifically designated to pay for Bonds.

There will be a tax increase on the I&S tax rate necessary to pay for the Bonds to service the New Bond Debt Payments, for a net overall total tax rate increase of \$0.069.


