The Clinton Central School District Foundation includes a Finance Committee, and a professional Investment Advisor who oversees the investment of the funds in safe, high yielding investments. An accounting firm provides an annual review of the finances and the reviews have always been extremely positive.

**REQUIRED MINIMUM DISTRIBUTION FROM YOUR IRA**

Individuals age 73 or older can make tax-free distributions from their Individual Retirement Accounts directly to qualified charitable organizations, such as the Clinton Central School District Foundation.

**MATCHING GRANTS**

The CCSD Foundation is a 501(c)(3) organization that is eligible to receive matching funds from many corporations. Several of our donors have taken advantage of this program and as a donor you may want to consider obtaining a donation match from your employer, if available.
