In the year ended June 30, 2022, the Foundation distributed \$591,635 to the Iowa City Community School District and other associated groups to support 29 schools and many school groups within the district. In addition, scholarships and awards totaling \$170,487 were distributed for the benefit of 45 recipients. The distributions and scholarships enhance educational opportunities for students.

The Visiting Author program, Symphony Goes to School, KinderTales, Any Given Child fine arts initiatives, Apple grants, and School of the Wild are all examples of programs funded by the Foundation in the 21 elementary schools across the District. Secondary buildings all receive funding to help further study in the areas of STEM education, building out seven MakerSpaces, the LiveArts@Hancher experience and a collaboration with the Coralville Center for the Performing Arts for every 7th grader. The Foundation, also, supports the staff of the Iowa City Community School District by funding SHINE awards and the Silver Salute celebration. These key areas of support are annually evaluated with the District administration to ensure what the Foundation is supporting are the right programs and opportunities for the students and staff. Restricted purpose grant requests are submitted, along with supporting documentation and substantiation.
