The Foundation solicits unrestricted contributions and manages and distributes restricted contributions for purposes restricted by donors. In the year ended June 30, 2021, the Foundation distributed \$842,611 to/for the Iowa City Community School District and other associated groups to support 28 schools and many school groups within the district. In addition, scholarships and awards totaling \$162,491 were distributed for the benefit of 68 recipients. The distributions and scholarships enhance educational opportunities for students.

The Visiting Author program, Symphony Goes to School, KinderTales, Any Given Child fine arts initiatives, Apple grants, AVID, Online Personalized Learning software and School of the Wild are all examples of programs funded by the Foundation in the 21 elementary schools across the District. Secondary buildings all receive funding to help further study in the areas of STEM education, building out seven MakerSpaces, the LiveArts@Hancher experience and working with Equal Opportunity Schools. The Foundation, also, supports the staff of the Iowa City Community School District by funding SHINE awards and the Silver Salute celebration. These key areas of support are annually evaluated with the District administration to ensure what the Foundation is supporting are the right programs and opportunities for the students and staff. Restricted purpose grant requests are submitted, along with supporting documentation and substantiation. Most requests are for reimbursement of expenses previously incurred by the Iowa City Community School District that allow the Foundation to monitor the use of the restricted purpose grants.
