





LLS Awarded \$500k+ CTE Equipment Grant





Lakewood Local Schools (LLS) is a recipient of the State of Ohio Department of Education and Workforce's Career Technical Education (CTE) Equipment Grant Program, which helps schools purchase up-to-date equipment so they can better prepare students to be career-ready upon graduation. LLS received \$530,916.01 and is one of 56 districts/schools receiving grants totaling more than \$67.7 million.

Lakewood High School currently offers the following courses in its CTE programming: Engineering Design, Robotics, and Manufacturing Operations. Through the grant, the district will train teachers and purchase technical equipment for the high school Innovation Center and middle school Industrial Technology room, furniture, and computers.

LLS will be expanding its existing Engineering and Science Technologies program with an increased focus on Advanced Manufacturing by adjusting its curriculum to offer a 12-point credential and a fourth course. As part of the program expansion, LLS would also implement College and Career Ready Labs at its middle school to expose students to the courses they can take in high school and generate more interest in the CTE Engineering and Technologies program, thus creating an aligned 7th-12th grade pathway.

Lakewood Middle School currently offers a Pre-Engineering Technologies course and the district will use part of these funds to incorporate Paxton Patterson College and Career Ready Labs into this program, such as CAD, Digital Manufacturing, Flight and Drone Technology, Robotics, and Structural Engineering.

Strategic Plan Updates


In early 2023, the Lakewood Local Schools Board of Education convened a diverse group of stakeholders including community members, parents, district staff members, and district administrators to consider and chart the future direction of the District. The resulting strategic plan includes a vision statement; a mission statement; core values; and five new, over-arching goals with clarifying goal statements.

For each of these goals, Action Teams have been formed and each group is creating strategies and tactics to achieve the goal. 




District Finances



To keep our community informed about the District's finances, we wanted to share information about the cost to educate a student per day in our District (\$94), as well as what portion of that cost is the responsibility of resident owners in our District (\$44).



Did you know?

Last school year, the District expended \$3.5 million in federal awards. Of that amount, \$951,000 was for Food Service activities, \$1.6 million was for COVID-19 ESSER activities, and \$949,000 was for Federal Title programming.

How Does Sports Betting Revenues Affect School Funding?

Unlike casino taxes which are allocated to individual school districts on a per-pupil basis, sports betting tax revenues are placed in a separate state fund which can be used for "public and nonpublic education purposes" at the discretion of the legislature. These revenues improve the bottom line of the state, even if they are directed to public schools through the state foundation formula, this does not result in any additional funding for Ohio school districts as the state is obligated to make these state foundation payments regardless.

The sports betting revenues are similar to lottery profits. They both free up an amount of money from the state General Revenue Fund (GRF) that the state can then choose to use in any manner they see fit. Neither the lottery nor sports betting will result in a net increase in revenues for Ohio's public schools.

Casino revenues received based on a per-pupil basis and received directly by the District for this school year is \$110,118.
