- 1. Welcome- Krista Tipton called the meeting to order and welcomed everyone and introduced the speakers for the meeting.
- 2. Krista provided agenda for today's discussion and action items.

 - A. Food Service Management Evaluation- Krista Tipton shared the information regarding the evaluation being in process.
 - B. B.Fitness Gram- Wendy Hein shared information regarding how the Fitness Gram works and how it tracks health/fitness. The categories that the state requires were reviewed and the note that this does not impact the student's grade. Annual Review.
 - C. District Health Plan- Wendy shared information about the plan and where it is located for view. She reviewed the areas that are included and that we build goals to be reviewed. This plan will be up for review next school year.
 - D. Recent MISD Health Initiative- Wendy gave information about each of these initiatives
 - a. Mammograms- in collaboration with Methodist, some were first time mammograms, hope to partner with Methodist for future initiative
 - b. Sports Physicals- in collaboration with Baylor Scott and White, provides assessments for students for sports
 - c. Immunization Clinic- held in conjunction with the Sports Physicals, great opportunity for students to receive immunizations and opportunity for parents to stop by and check on current shot records.

4. Discussion/Action Items-

A. YES Programming: 5th Grade Puberty & Adolescence- Krista shared the updates to the TEKS. This is an opt-in for parents and communication will go out about the district plan for this topic. Krista reviewed the information that was given to us last meeting regarding the curriculum and materials that were shared. Nikki Lane, partner from YES, was present to answer any questions about the programming. Krista shared with the committee how we are working through grant money and funding for the programming because this is required by the state. The vote today is regarding approval for the use of the programming, but this still has to be taken before the Board when/if/after the SHAC committee approves.

Krista asked if anyone would like to make a motion. Motion was made by Amanda Brady to adopt the programming to meet the TEKS. Second was made by Lonna Edwards. Wendy Hein then shared the poll for all members to vote.
