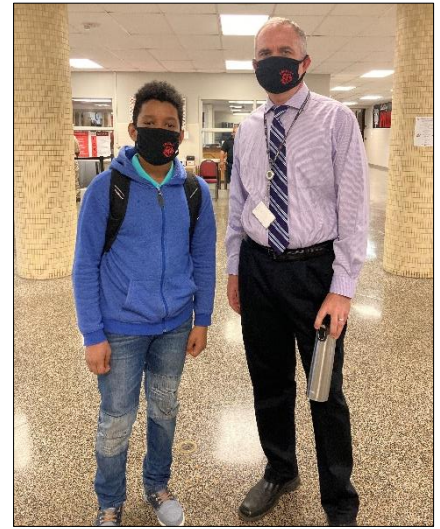

Leadership Message

Dear Friends,

After writing to you last year about the “Pre-Covid” and “Post-Covid” times, I didn’t imagine writing again this year and still talking about the effects of Covid-19. Yet, here we are. Like many other community serving organizations, the Allentown School District Foundation (ASDF) performed the “Pandemic Pivot” in 2020-2021 and we learned to support the Allentown School District students and staff in new ways. You, our supporters, also pivoted by participating in the first Virtual Gala and through our most successful Annual Appeal in Foundation history. This speaks to the commitment in the community to providing positive educational experiences for students in the Allentown School District (ASD). We cannot thank you enough!

PANDEMIC ASSISTANCE

- We thought schools would reopen in fall 2020, so the ASDF engaged to provide school logo face masks for students and teachers in all of our buildings. We thank the 15 individuals and organizations who contributed to this effort. The 19,456 face masks were finally given to students and staff when they returned to school in 2021.
- Conduit partnerships continued to expand including a Lehigh County grant of \$2,082,237 for school infrastructure projects including air filtration upgrades, touchless drinking water stations, germicidal irradiation of HVAC and isolation rooms.
- Through a \$240,000 grant from the Century Fund, the ASDF funded 1000 household Wi-Fi hot spots each month for a year.
- The ASDF secured a donation of 18,000 bottles of hand sanitizer from McKesson Corporation that were distributed to all schools in April for the re-opening of schools.
- ASDF donors assisted with food programs for families in need.
- Bach Choir of Bethlehem created “learn at home” packets to accompany their new *Bikes, Bach and Basketball* video series and the Foundation paid for postage so every 5th grade student in the District could receive a packet delivered to their home.
- Some of our Volunteer Readers were able to continue to assist our kindergarten and first grade students throughout the pandemic using technology.

RE-ENGAGING STUDENTS

Late in the year, the ASDF was able to fund some new requests to help keep students engaged in school:

- William Allen High School students participated in a legacy mural project under the direction of School Counseling Intern from Kutztown University, Lana Gonzalez (WAHS '15)
- Gala Grants were awarded to 13 performing arts groups at the four middle schools, and Louis E. Dieruff and William Allen High Schools. Teachers use the grants for student workshops (poetry, jazz, and dance); instrument purchases and repairs (including ukuleles); music and show rights; costumes and uniforms; and anticipate using funds for service trips and transportation.
- Literacy Volunteers are welcome in our schools this fall following all ASD Health and Safety protocols. New volunteer orientations are held monthly for this important effort to help all students read by grade 3.

OPERATIONAL UPDATES

- Our Board's Finance Committee participated in two rounds of Paycheck Protection Program (PPP) Loans to help the Foundation maintain its sound financial position without laying off staff.
- Four new members were elected to the ASDF Board of Directors this year: the Honorable Rashid Santiago; D'nese Sokolowski, MD, (WAHS '88); Erika M. Sutherland, Ph.D.; and attorney Donald E. Wieand (WAHS '69). These members bring a depth of commitment to the community through their many community and service organizations, and a wealth of knowledge and experience to help lead the ASDF. We are grateful for their decision to serve.
- The Foundation Board bid adieu to long-serving, active, and dedicated Board Members: Dr. John Stevens, Mr. Tony Muir and Dr. Dennis Blankowitsch. Fortunately, all continue to help the ASDF and serve on Committees as they were, and continue to be, instrumental in directing programs and assisting with oversight.
- The leadership baton was passed from Executive Director of 5 years, Susan Williams, to Dr. Julie K. Ambrose (P WAHS '12). Julie began in January and Susan stayed on to design and implement the Virtual Gala in March.

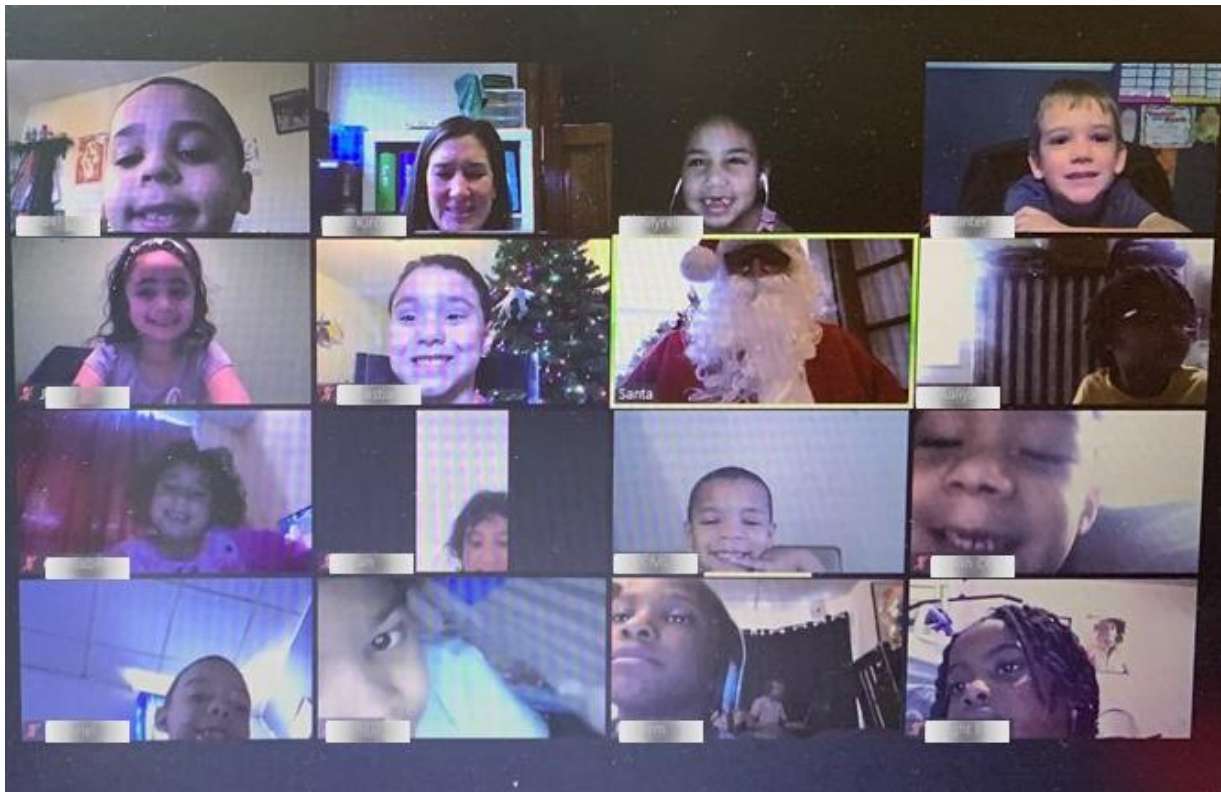

Conduit Gifts

One of the Foundation’s most significant Pandemic Pivots was the shift from providing programs for student enrichment to providing fundamental needs to help students and teachers engage in on-line classrooms and assist the ASD with building modifications. This was possible through the conduit gift opportunity program, one of the ASDF’s most important programs.

During this year, the Foundation served as a conduit for more than \$2,235,328 of charitable gifts and grants for the District. Because the Foundation is a 501(c)(3) not for profit corporation, individuals and corporations may make general or specific tax-deductible contributions to the Foundation for the direct benefit of the District. The largest conduit this year was over \$2,000,000 from Lehigh County for Covid-19 related school renovations to ensure a safe learning environment for staff and students. The community showed strong support for the ASDF to fund school logo face masks for all students and helped fund technology devices and Wi-Fi so students could learn at home.

Conduit donations were given for the Muhlenberg Elementary School playground project spearheaded by teachers at the school and for Dieruff High School Learning Dome enhancements. A multi-year effort to fund new stage lighting at Dieruff High School (DHS) concluded thanks to the generosity of the DHS Alumni Association’s Roy Arlotto Campaign, the Theatre Department, individual donors, and a grant from The Harry C. Trexler Trust.

Public school funding inequities were exacerbated because of Covid, yet this community pulled together to support the ASD’s 16,000+ students. The Foundation would like to thank generous foundations, corporations, organizations, and individual donors for their gifts and encourage others to consider making a “conduit gift” to the Foundation for the benefit of ASD.

Senior Scholarships

The following 57 graduating students received 63 scholarships through the ASDF, all funded through generous donor gifts. Endowed scholarships (**in blue**) are those in which the gift is invested, and a portion of its income is awarded annually (2021 distribution rate: 5.0%). The principal for endowed scholarships must be at least \$10,000 and cannot be expended so that the scholarship can be awarded in perpetuity. The funds are managed by a professional fund manager and supervised by the ASDF Investment Committee. Expendable scholarships (**in black**) are those in which the gift, or a portion determined by the donor, is awarded annually. A total of \$54,804 was awarded to 2021 graduates, while alumni from the classes of 2018, 2019 and 2020 continue to receive their Roland & Louise Neuweiler Wotring awards bringing the total scholarships this year to \$110,488.

Teacher Innovation Grants



As one of the Foundation's signature programs, Teacher Innovation Grants (TIG) has offered ASD students enriched learning opportunities since the first grants in 2010. Since then, more than \$143,000 has been granted to 147 ASD educators. TIG grants provide funding for teachers, school counselors, coaches, and nurses to develop original in-class or extracurricular projects that inspire students to go beyond routine day-to-day learning. Grant recipients are chosen on a competitive basis with grants of up to \$1,200 per applicant.

Due to the hands-on nature of these projects and school being held virtually during spring 2020 and most of the 2020-2021 school year, no new TIG grants were awarded during this time. Instead, the 24 recipients from 2019-2020 were given an extension until May 31, 2022 to complete their projects. Some of them are featured in the photos below. Our TIG Committee of dedicated volunteers looks forward to selecting additional recipients in 2021-2022 and showcasing their projects at a spring reception.

TIG grants are made possible by contributions from many supporters such as the Bill Sugra Memorial Fund and the Allentown Education Association. Since TIG is one of the Foundation's most impactful programs, we are especially grateful for sponsors. 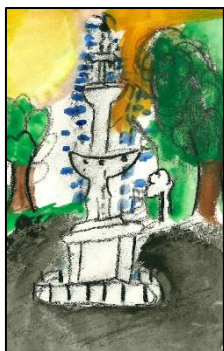

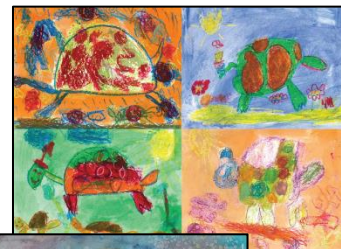
