THE ASDF NOR ITS BOARD MEMBERS MAY BE INVOLVED IN ANY SELECTION PROCESS. A MINIMUM OF \$10,000 IN GIFT(S) IS REQUIRED FOR A CONTRIBUTION TO BE CONSIDERED AN ENDOWED SCHOLARSHIP.
