THE FOUNDATION'S VOLUNTEER BOARD OF DIRECTORS SEEKS INDIVIDUAL CONTRIBUTIONS, FOUNDATION GRANTS, CONDUIT GIFTS, AND OTHER FUNDING SUCH AS EITC CORPORATE CONTRIBUTIONS FOR PROGRAMS THAT PROMOTE EXCELLENCE WHILE RECOGNIZING THE ACCOMPLISHMENTS OF ALLENTOWN'S 16000+ STUDENTS AND 2100+ EMPLOYEES. IN THE 2021 SCHOOL YEAR, CONDUIT GIFTS WERE USED TO SUPPORT COVID-19 SCHOOL REMEDIATION PROJECTS TO ENABLE STUDENTS TO RETURN TO SCHOOLS THAT WERE SAFER. THE FOUNDATION ALSO FACILITATED DISTRICT SUPPORT FOR WIFI HOTSPOTS. ADDITIONALLY, THE FOUNDATION RAISED CONDUIT FUNDS TO PURCHASE A SCHOOL LOGO FACE MASK FOR EVERY STUDENT IN THE DISTRICT. CONDUIT FUNDS ALSO SUPPORTED COVID-RELATED MEALS FOR FAMILIES, THE RAMOS ELEMENTARY SCHOOL PLAYGROUND, AND LEARNING DOME ENHANCEMENTS.

TO INSURE AWARDEDABILITY, NO MORE THAN TWO CRITERIA BEYOND HIGH SCHOOL DESIGNATION ARE USED IN DETERMINING SCHOLARSHIP RECIPIENTS MAY BE SET. THE SELECTION PROCESS IS AT THE DISCRETION OF THE BUILDING PRINCIPAL. WHILE DONORS MAY DETERMINE ELIGIBILITY CRITERIA, DONORS MAY NOT BE INVOLVED IN THE SELECTION OF INDIVIDUAL SCHOLARSHIP RECIPIENTS. THE ASDF NOR ITS BOARD MEMBERS MAY BE INVOLVED IN ANY SELECTION PROCESS. A MINIMUM OF \$10,000 IN GIFT(S) IS REQUIRED FOR A CONTRIBUTION TO BE CONSIDERED AN ENDOWED SCHOLARSHIP.

DURING THE 2020-2021 SCHOOL YEAR, THE BACH TO SCHOOL PROGRAM WAS DELIVERED VIRTUALLY TO ALL FIFTH GRADE STUDENTS IN THE DISTRICT, RATHER THAN VIA THE TRADITIONAL FIELD TRIP TO HEAR THE BACH CHOIR AT WILLIAM ALLEN HIGH SCHOOL. FUNDS WERE USED TO SUPPORT MAILING INDIVIDUAL PACKETS TO EVERY FIFTH GRADE STUDENT'S HOME. FUNDS WERE ALSO USED TO SUPPORT THE RBI BASEBALL PROGRAM, I AM ON A BOOKSHELF PROGRAM, MIDDLE SCHOOL TRANSFORMATION, VISUAL AND PERFORMING ARTISTS (INCLUDING A MURALIST AND MIDDLE SCHOOL STRINGS LESSONS). GRANTS WERE GIVEN TO THE FOUR MIDDLE SCHOOLS AND DIERUFF AND ALLEN HIGH SCHOOLS TO SUPPORT CHORAL AND INSTRUMENTAL MUSIC, THEATER, POETRY, AND DANCE PROGRAMS.
