#### Mission Moment

#### **EXLENT Explorations Grant**

A DeSales University professor, Dr. Brennan Pursell is seeking a National Science Foundation grant to have 3-year program for ASD students for Data Analytics. We have been invited to be a partner to pay the students (distributed from the grant money). We created a budget to cover our expenses. We won't know for a few months if he is awarded the grant. There was discussion about the program with some suggestions to strengthen it.

#### Student Representatives 2023-2024

We have reached out to ASD to make sure that we are in the loop to get student representatives. We want to ensure that the experience is worthwhile for the students so Board members are encouraged to think about ways to involve the student representatives.

### **Board Education – Intro to ASDF Finances (F)**

## Restricted vs. Unrestricted Gifts:

Restricted: Donor designated purpose. Unrestricted: ASDF decides how to use it.

- Examples of Restricted Gifts: Scholarships, I am on a Bookshelf, Conduit.
- Examples of Unrestricted Gifts: Annual Appeal and Gala
- Gift Categories that Impact Programming: High Notes, Grants, EITC, Annual Appeal.
- Gift Categories that are Separate from Programming budget: Scholarships and Conduits.

<u>Grants</u>: We have to apply, and may or may not receive the grant. Apply—Implement—Report. May or may not apply administrative services fee, depending on criteria.

Relationships matter. Board members may hear of grant opportunities. Companies who give grants always ask: Are any of our employees associated with your organization?

Julie writes most of the grant applications. Julie is building relationships with grantors. Some conduit grants are written by others with Julie's help.

<u>2023-24 Budget Goal for Grants</u>: \$116,750. Some grant monies come in during a different FY than the program itself.

Some grantors happily give every year. Some rarely give to the same program for more than one year.

<u>EITC</u> (Educational Improvement Tax Credit): Comes through the Pennsylvania Department of Community & Economic Development. Businesses need to be approved to give money. Nonprofits need to be approved to receive money.

<u>EITC Budget Goal</u>: \$76,750 (higher than last year). Restricted to varying degrees based on the donor.

<u>Annual Appeal</u>: unrestricted gifts. Goes out in November. Budget Goal: \$80,000 <u>High Notes Gala Goal</u>: \$125,000. Sponsors & Advertiser support is key to fundraising. Student showcase is important, and has costs associated with it. Silent Auction. Some companies require grant applications and reporting for Gala sponsorship.

#### **Scholarships**:

*Expendable,* used until it is gone. *Endowed,* only use part of interest income. Investment Committee determines amount.

- Expendable: Minimum gift \$1500 usually
- Endowed: Minimum gift \$10,000

Donor guides criteria. The designated high school selects recipient. Single or multi-year. Funds sent to college. No ASDF fees.

2023: \$65,789 Awarded to 2023 Seniors. About \$30,000 to students who had graduated earlier (from multi-year scholarships).

<u>Conduits</u>: Formal: We create an agreement that is signed by ASD, ASDF, and 3<sup>rd</sup> party *Informal*: (RBI Baseball) history of support, assist with grant applications, grant reporting, pay invoices for programming and equipment.

Conduit Fee: between 0-4% depending on the work effort.
