- Board Member Nominations: With Ellen Kern's resignation we have a current vacancy, but still have 19 Board members. Our bylaws call for no less than 9, no more than 30 on the Board.
 - Last year had a 3-week nominating period; vetted nominees with a Zoom interview. We are seeking to increase the diversity of the Board. If people have nominations, please talk to Rashid.
- **Emeritus Board Members.** Last year was inaugural year. We now have 5. We don't have a set number to aim for. Rashid will send out information for nominations.
- Officers: Expectation that Vice President will become President. Tonya is ready to transition to President. Ibi (Treasurer) and Maria (Secretary) are willing to continue in their roles. Leaves us with VP vacancy.
- Immediate Past President: Executive Committee discussed creating an Immediate Past President position. Some other boards have this model. This would provide support for incoming President. Could be a non-voting position or voting position. It would only apply when the President's term ends at the same time as his/her Board term. After discussion, it was determined that the Governance Committee should give definition to the role and bring the issue back to Board in April.

DonorPerfect Training Vote

The Board passed an E-vote to have the staff receive DonorPerfect training. (Need 80% majority when do an E-vote.) Julie mentioned that the training will be very helpful with a new bookkeeper coming in.

EITC Update (E)

Quite a few grants. MidPenn Bank was new EITC. We have 2 that we hope will still come through. Always looking for new or increased grants so encouraged Board members to let her know if they are aware of any possible sources.

Gala Update (F)

- Sue Williams is helping with sponsorships.
- 170 sponsorship packages mailed.
- 652 invites mailed and others delivered by hand, 83 invitations were hand addressed and delivered to ASD administration.
- Email blast: 288 people opened email.
- Sue reached out to 88 individuals or companies about sponsorships.
- 8 completed company grant applications; 6 more in process.

- Have 1 Maestro and 2 Sopranos.
- Thanked Board members who have reached out to companies or have done own sponsorships.
- Ticket sales now available. Still seeking advertisers which helps a lot.
- Budget goal is \$122,000 in revenue (including Broadway Sponsors) with a net goal of \$81,800.
- Should be a great night. DMC Duo (With John Stevens' daughter) will be performing after student performances for dancing.
- Excitement building for the evening. Auction is gearing up.
 Scholarships

Dick Button is reaching out to donors who funded past expendable scholarships. The Investment Committee looks at how endowed scholarship investments have done and decides on the draw. This has been a bad year for investments. Funds haven't grown and some even lost money. We can't use principal so it may be more challenging to give out scholarships. May be looking to boost general contributions to support scholarships. Have moved to a formula of a 3-year average for deciding draw.

Strategic Planning Update (G)

Strategic Planning Committee making great progress and is right on target on time-line. Four priorities: 1. Fundraising Optimization; 2. Programmatic Quality and Innovation; 3 Operational Excellence; 4. Collaborative Support.

Looking for input from Board members to develop about 5 goals for each Priority Area. The Committee invites comments for specific goals.

There will be a Strategic Planning Committee meeting this month.

Spring Residency Programs (H)

Have Proposed Residency Programs for Spring Semester. Programs are done on a rotating basis, with 4 or more elementary schools each semester. Elementary Newcomer, Union Terrace, Muhlenberg, Jefferson and Central will participate this spring.

Animals on Stamps project: Partnering with Allentown Philatelic Association. (Using funds from a City Center grant for Central.) Open to all ASD student, with prizes and exhibit at Allentown Art Museum. Will work into our residency programs but will also be in schools where we do not have a current project. Will involve at least 580 students.

There was discussion about the importance of arts programs.

Erika requested that permission slips be in English and coherent Spanish. If a parent does not understand a permission slip, it disinclines them to have child participate.
