Will also give ASD an opportunity to get feedback from organizations so we can work together. Connect school day with what kids do after school in the community.

Life-skill support teacher Kathleen Dent requested funding for Canary Nation Games Program. Like Special Olympics; Special Ed students partnered with other students. May 24th 8:30-1:00 p.m.

Total cost was \$5000. They were able to get the rest and asking us for \$600 to cover costs.

Investment/Scholarship (D)

J. Dodd for R. Schmidt

March 14 Investment Committee met. Applied a 3-year Market valuation: 4.4% recommended to distribute.

Motion to accept distribution percentage: 1st Maria 2nd D'nese Conclusion Approved.

Scholarship (E) D. Button

Explained that Expendable Fund Scholarships: go directly to scholarships (rather than set up as an endowment). Set up by the donor as to how much to give. Wotring Scholarship provides 4-year scholarships.

<u>High Notes Gala</u> D. Sokolowski

Thanked everyone who made it a great success. Budgeted \$80,000 revenue and \$32,000 expenses. Final numbers are not available but it looks like our gross income was over \$100,000 Expenses: \$25,000. Silent Action raised about \$3500. 150 attendees. Hope to have more attendees in the future.

Applaud efforts of the committee. Rewarding to see the students perform. Challenge to Board to expand the attendance of administrators, teachers, community members, etc. Thanks to D'nese, Julie,

Vicki, and others (including Board members on Gala Committee: Tonya, Dan, Jane and volunteers: Maria and Kay). D'nese was urged to continue as chair. It was suggested that unsold Silent Auction items might be listed in the ASDF newsletter, inviting people to buy them.

Governance (F) R. Santiago

Highlighted 3 areas:

<u>Board Leadership Roles</u> Thanked members for nominations. Received nominations for each position. Will be following up with nominees.

<u>New Board Members</u>: 3 vacancies. Will ask for nominations within 2 weeks. Will send out *Commitment to Serve* form with nomination form.

<u>Emeritus Board Members</u>: Received several nominations for this inaugural year. Discussed whether to limit number of members who can before Emeritus. The by-laws are silent on the number per year. The general feeling was to include those who meet the stated criteria. We could revisit limiting the number of Emeritus members if it becomes an issue in the future. Will follow up to see who is interested. Rashid was thanked for his work.

Both funded through EITC

Literacy Volunteer Program

Monthly trainings. Have 60 volunteers going into schools. Goal of having a 100 per school year. Were close before pandemic. Think we can get close to that by next year.

<u>Summer Programming</u>: Summer Camp opportunities. 7 summer programs. They are giving scholarships for camp opportunities for 30-40 kids in exchange for ads in the Gala program. From a previous effort, Wells Fargo is giving scholarships for 12 middle school students to go to Camp LCTI and providing bus transportation.
