### **Other Bank Charges**

Bank charges such as wire transfers, collecting outstanding checks/drafts, bounced checks are the responsibility of the parents.

### **Overdue Payments**

Fees not paid by the due date are subject to interest at an annual rate of 10%. Non-payment of fees may result in the student not being allowed to attend classes and/or withholding the student's academic records.

## **EXPLANATION OF FEES**

### **Application Fee**

A non-refundable fee of \$800 for each application. The application fee is valid for a two-year period from the date of submission.

### **Re-Enrollment Fee (Returning Students)**

A re-enrollment fee of \$2,000 is required by **March 15** to reserve a student's space in the upcoming school year. This amount is credited against tuition. From **March 16**, there will be an additional late fee of \$500. The re-enrollment fee payment is refundable until **March 31**. After this date, the re-enrollment fee is non-refundable and is subject to space availability. Re-enrollment of any student is subject to school approval.

## **Advance Deposit (New Students)**

A non-refundable payment of \$2000 is due within 10 days of accepting an admissions offer. This advance deposit secures the place for the student and will be applied to the total school fees payable.

## **One-time Registration Fee (New Students)**

A one-time, non-refundable fee of \$16,500 for newly enrolled students. \$10,000 applies to newly enrolled PreKindergarten 3 students and a balance of \$6,500 will be charged in the subsequent year if the student continues in PreKindergarten 4.

## **Tuition Fee**

Tuition fees vary by grade level. See Fee Schedule for details.

## **Extended Service Program (ESP) \*Fee is mandatory**

Students placed in the Extended Services Program require a modified curriculum. To support their learning development, students require instruction to be delivered in a separate location with a low student-to-staff ratio. This plan will be developed by an integrated team including the School Administration, School Counselor, Special Education Teacher, Educational Psychologist, Occupational Therapist, and Speech & Language Pathologist. The Extended Services Program classroom is a purpose-built space that allows the students to focus on individualized academic instruction and develop functional independent life skills.

## **English as an Additional Language Fee (EAL)\*Fee is mandatory**

EAL fees vary by grade level. See Fee Schedule for details.

## **Absentee Acceptance**

An absentee acceptance may be secured by a qualified applicant at the discretion of the Admissions Office. This paid option reserves an available seat in the current semester for one child who is not yet attending AES.

## **Payment of School Fees**

**For new students**, fees are due within 30 days of invoicing or before the first date of joining, whichever is earlier. The School may require payment of all school fees at the time of admission (due to enrollment limits, wait pool, or other factors). For the second semester, fees are due by December 19.

**For returning students**, the re-enrollment fee is due by March 15, 2024, and all other school fees must be paid by May 31. Failure to pay all school fees by the May 31 deadline will result in a late payment fee and may also result in the student losing the space for the upcoming school year.

In the case of a force majeure event, the Director of the School will act in the interest of the students.
