PUBLIC HEARING ON THE 2016-2017 PROPOSED TAX RATE

A Public Hearing on the 2016-2017 the proposed Tax Rate will be held at the Administration Building located at 11119 Military Hwy, Santa Maria, Texas.

Any taxpayer of the District may be present and participate in the Hearing. [Policy CE (Legal)/CE (Local)]

1. Presentation on the proposed Tax Rate for the 2016-2017 school year

Mr. Cuellar stated as per the information that was provided by Estrada/Hinojosa and our current tax rate we had the maintenance and operations taxes remain at \$1.17 the debt service was at 11 cents and due to the changes and because of the bond issue and so forth the proposed tax rate as per our financial advisors we were told to go ahead and pull 31 cents. This is the way we published it in the newspaper and the website and as Ms. Chavez said our taxable values did go up, both the appraised and the taxable, so this is what was advertised and the bond indebtedness at that time that we had last year is at \$5.1 million in debt and that's based on our audit report from last year 2015. As you can see it shows the difference in last year's rate and how much local revenue for student and state revenue per student and based on the increase the proposed rate is \$1.17 is 31 cents a total of \$1.48 and the increase of revenue per student local increase in revenue per student state. The next section shows the proposed levy and this is based in the taxable market value of residences and other property's. It also compares last years to this years. Based on the comparison, it shows an increase of \$55.88 per taxable value per residence on average.

The next section shows the rollback amount that is calculated at \$1.48 for the rollback rate. At the end it shows the estimated fund balance that we have to advertise with this tax rate proposal with a \$2.57 million in maintenance and operations and \$37,224 in I & S.

Ms. Chavez stated I also want to remind you that the tax rate at \$1.48, we are going to be looking at that same tax rate for the next two years as we pay off the initial series of those bonds and then when we come back after those two years were actually going to lower it even less than where we were prior to the bond issue.
