SUPERINTENDENT'S REPORT

Ms. Chavez stated I recommend that we approve the agenda for the regular board meeting for November 7th 2016 with no modifications or deletions. I did consult with the attorney with regards to the posting at 6:30p.m. and I referenced that to the 6p.m and we are clear because the posting was made for 6:30p.m. We had no visitors or anyone other than the individuals present for 6:30p.m.

1. Student Attendance/Enrollment

Ms. Chavez stated we were at 95.93% overall attendances at the district level. We are working very closely with the Middle School as well as the Junior High to ensure that we continue showing that high attendance district wide and the same at the Elementary School. The overall enrollment at the district level is 690 students. We are working with the administration to ensure that we are promoting our programs, initiatives, as we have open enrollment district wide and to ensure also the conversation with employees that education at Santa Maria ISD is good enough for my child and we have employees also who have transferred their children to our district.


Presentation of 2016-2017 Campus Improvement Plans

Mr. Campa stated one of the main issues that we got this year that we turned into a positive was our Early Literacy Reading Initiative through the new curriculum that we just acquired through the Pre-K Grant. It's called Opening the World of Learning. We did have the Pre-K guidelines knowing that it was the only curriculum we had so the teachers are working close in hand with the DWL which is another curriculum that was meshed together and being worked on as one and now we actually have a set curriculum that's aligned with the stated. What that does is it's designed to develop an oral language and early literacy skills with our students. It offers equitable instruction in English and in Spanish as well and it's a good English language development and we do that every day. We also developed a language in early literacy skills in Reading, Math, Science and Social Studies. The great thing about that is it's a comprehensive curriculum aligned to the Pre-K guidelines and not just for Pre-K but also College and Career Readiness initiatives that we have going on so it prepares those students to close those gaps between those four core subject areas in an earlier stage and were able to move forward with this initiative. So that is the new initiative that we are looking at the lowest level to align and set that critical foundation that is needed for those students with that early reading.

Ms. Chavez asked can you briefly expand on the learning walks.

Mr. Campa stated we are doing some learning walks with our administrators and teachers. We schedule those in and we also work with our Superintendent coming in to the School District with other campus administrators and what we do is we go and find a specific area we want to target which is Rigor or even accountable talks between the students and right now those were the main focuses in the Elementary and in Middle School because we want to ensure that it was rigor to where we could address that advance in the performance. Our students are learning at this level but we want them to be at the best level possible which will ensure all passing at the State level and that really brings us to the next level.

With the learning walks our teachers have been able to identify what's been missing in the rigor. We did find a lot of information that they might have had misconceptions about but they corrected those misconceptions and now they are on the same page and we will keep moving forward.

Mr. Abeyta stated at the Junior High we are working on is in converting all of our classes to a student centered instruction. We are taking away from teacher center to student center which is the key part of TTESS and TPASS that the student is first in the chart. As we do the learning walkthroughs, what we're looking at is making sure that classroom is student centered. Small group instruction, each group may be at different levels so we don't have the teacher just giving a lesion because you may have certain students engaged and other students disengaged because they already got it and they are waiting to move forward. So they are placed in small groups and the teacher is mainly becoming a facilitator and if the students are going forward with the lessons and the teachers are designing the lessons using Google Classroom so there's a lot of technology being used in the classroom as well and it's all around the student. So that's one of our biggest goals and as we look at our learning box, that's what we're looking for, to make sure they are student centered classrooms. We analyze the data and our advanced students weren't scoring as high as we felt they should be so they were not scoring a level three which we should have had more student hitting level three so were trying to stimulate their interest in the classroom by putting them in the center of the instruction and the teacher becomes a facilitator.

Ms. Taylor stated for the High School some of the things we have improved on is the college and career readiness but let me start with our special populations for our LEP. Our teachers receive Cyop training and they also use online resources like Rosetta Stone. This year we integrated Edmentum which is completely district wide. We are seeing improvement. We started doing comparison reports literally from preassessment to the first six weeks compared to the second six weeks and you can see that we compared the general population to the SPED, Migrant and LEP and you can see where the LEP is actually doing better that the general population. And it was all that work that was done prior and it continues to be done. For the Migrant, they are receiving assistance in the classroom so the individuals have a schedule where they are not going into the classroom throughout the day. We are all pretty much involved in the pack meetings for the parents as well. For the SPED students our teachers district wide receive accommodations and modifications training because sometimes they have the IEP forms that they have to follow but it assumed that they are doing it but sometimes we find out that we are not doing exactly what were supposed to be doing and it has to do a lot with training so you have to kind of revisit that training to make sure that you're doing it correctly. We have also received training in the ARD process. Also Santa Maria has taken on another initiative which is a student learning objective process and when you hear student you think well the teacher is studying their goal based on the student and that is correct but the process is now the teacher. It used to be that the teacher would set a goal and they still do for the student but now they are setting goals for themselves under this process. They have to see what it is that they have to do to change or move in order to improve on so that I can ensure that my students are being successful. We are doing this district wide and I believe we are the only school district. We are doing this because next year it is going to be a requirement. Also some of the areas as far as one of the things we talked about last year was the State of Texas had said that schools need to offer at least two endorsements of their schools. Considering that were are a small school you would offer at least two areas where your students are going to get certified in or a pathway that they are going to follow which is Business and Industry, Arts and Humanities, Public Services, STEM and also multidisciplinary studies and in

Santa Maria we offer all of them in some way all five. Our certification program is another one. It's all about College and Career readiness district wide and we are already seeing that coming from Elementary, Middle School and Junior High, that they are getting prepared because were moving forward. At the High School last year we had 11 different certification programs and now we added 6 additional so we have a total of 17 areas that students can get certified. That's a lot of areas but it's a possibility if the student is really focused on that they can get it done. So with that being said all the initiatives that are being put in place are going to be very successful and it's been a work in progress and were going to get there.

Ms. Chavez asked can you go over all the certification areas.

Ms. Taylor replied currently it is Dental Assistant, phlebotomy and clinical and medical assistant. The Electrical Apprenticeship, FEMA Certification the Jailors Academy, First Aide Certification, CPR and AED Certification, CAN Certification, the Principals of Livestock Evaluation Certification, Fundamentals of Science, Food and Safety of Science, OSHA Safety, the Southwest Airlines, Cosmetology, and Office and Technology Certification.

3. Texas Consolidated School Rating- 2016 Community Engagement Report

Ms. Chavez stated this is the document for you and this is the new reporting that also adds the additional report which is the community engagement piece and within that document it also gives you a historical of the rating for that particular campus and you have the district rating and it gives you a historical from 2013 to 2016 so as a school district we have met the standard for 2013 thru 2016. At Santa Maria High School we have met the standard from 2013 to 2016 and of course you have the DEAP which is not rated and the same thing with Santa Maria JJAEP not rated and then you have Santa Maria Middle School historical from 2013 to 2016. This past year we met the standard. Last year it was an improvement require. 2014 it met the standard and in 2013 it was an improvement require and Tony Gonzalez Elementary met the standard for the last two years and this was a campus that was in an improvement require in 2014 and 2013 in improvement require. The critical areas that you have there is also the distinctions or designations and one of the areas at the secondary level, the progress, the closing of that gap, the high percentage of students that are reaching as Mr. Campa mentioned. Many of the students who were not reading at grade level and also at the secondary who maybe in 7th or 8th grade and as they are seeing, the student may still be reading at 5th, 6th, 7th and so on. That particular distinction focuses on how many students are moving up to grade level performance in closing the gap. And then the remainder of that report gives you the areas that rated for that community engagement and were conservative as a school district because much of that is determined based on that review but you have the overall performance for that community engagement. You have Fine Arts recognition there for SMISD and then you have the wellness physical education and that is data that is submitted though the PEIMS system. The community parent engagement is based on the number and type of activities that the school district conducts and the 21st Century Workforce connection that includes the industry certifications as a school district as we continue adding and improving in those areas. In second language acquisition as you're looking at the implementation of Bilingual and ESL programs as a school district and then the digital learning environment and how we implement that initiative as a school district. Dropout prevention as well and then the Gifted and Talented programs and then the last of that is the Statutory Compliance with all Federal Programs regulations in this case.

Ms. Ortiz asked if the tutorial program was also for students that did not pass a class the previous six weeks.





Mr. Abeyta replied yes we reevaluate every six weeks and if we have to add some students on to it then yes. If we have students that weren't successful in their classes they are automatically put into the tutorial program so that they are going to be successful the next six weeks.

4. Presentation of TAIS School Improvement Plans for 2016-2017 MS. Chavez stated as a school district we are not required to submit and of the plans because our school is already passed the required improvement but we are required to develop the plan and to continue working to ensure that we maintain and sustain the academic progress so we go through the process and working with the PSP to continue with the focus. Can I have the Middle School and Junior High speak to that process and what the highlight was?

Mr. Abeyta started by saying we have been working with Mr. Santillan and Ms. Moreno. They come down to work with us from Region One to help us develop a plan. We sat down with the campus improvement team and campus leadership team, myself and some teachers and Mrs. Monreal. We go through each question that is asked in the test and we develop a plan. The key part of this is they want to know what the root cause behind a particular result on the test is. Once you get to the core we develop a plan based on that and we set some goals based on each quarter. There's a quarterly goal that we have to meet and then we have to identify if we achieved the goal or not but we set goals for every quarter and then we meet every quarter to review and to see if we have to update. They also come and do walkthroughs with us for the TAIS on campus and then based on what we put down we then do observations in the classrooms.

Mr. Campa stated it's pretty much the same thing with ours at TGE and also for the Middle School. Our plans are mainly for each one of the campuses and we use root cause analysis to break down what exactly is for example if we only have 45% of our students passing we want to know why. We ask those five questions and follow that pool process. The five whys and then continue to the root cause. Once we determine how to set our new goals based on that and like he said, we monitor every quarter and then within that goal we find out what data we are going to collect and if there were any changes for that first quarter then how do we make that change. It also asked if we're on track or not on track to meet that goal and if were not on track then what do we have to do to different get to that next level. So we have certain goals within each quarter but we have a final goal at the end of the year. So that's how we monitor that all the way through July so we have worked with the TAIS improvement plan and that's a process we've been following out since I started here which is about five years.

Mr. Abeyta stated the goals will start with training. The first quarter goals are usually training. How are you going to train your teachers to get them ready? then you progress from there. So after the training you take the next step and usually by the third quarter or the fourth your actually measuring the gap. So first quarter is training the teacher, second quarter is usually implementation into the classroom so it's very guided step by step.

Ms. Chavez stated can you elaborate on the depth of knowledge with this new assessment. What does that mean for the teacher in delivery?

Mr. Abeyta replied the depth of knowledge or DOK level 1 is basically root memorization because you will pick up just remembering of vocabulary words and definitions and its actually asking you to explain, elaborate and describe using different types of vocabulary words that students have to ask that takes us to the depth of knowledge levels two and three where you often have to explain why something happens and explain your answer. That's what they want the students to do because that's what is going to continue to take them to their level three success in their STAAR exams. Depth of Knowledge four is usually like if you're going to design lab experiments or design some type of program. Depth of knowledge levels two and three is where were moving our students right now is to explain and elaborate.

Mr. Campa continued and we cover the PLD which is the Performance Level Descriptors for each one so we noticed that it also goes back to teachers. If there reaching at that level one they are getting those questions on the test and that's what you're seeing a lot of those questions being answered at that level. So performance level two, PLD 3 that goes back to the DOK's. With that in mind the teachers have to now figure out well I'm asking this question so how do I make it a two or a three because the rigor of the test is tougher now and that's why we target the rigor a lot.

Ms. Chavez stated we are basically reviewing the questions to ensure that the assessments are balanced in terms of the levels of those questions. If see level one and two and that is pretty much the whole assessment and we know the rigor is not going to be there and the kids may score high but when they face the actual assessment which is questions three and four then they're going to perform poorly on those types of assessments so it's all about providing the experiences and it starts with the regress delivery and the types of questions they are asked.

Mr. Abeyta stated they were consistent in class curriculum too. They asked those questions those verbal questions in English so the students are seeing the same level of questions in Math, Science, and Social Studies. We are looking at several packages of test generators that do that for us so all teachers are on the same sheet of music basically when they are creating a test and it makes them bring their lessons up to that depth of knowledge.
