1. Presentation by Adrian Webb, Certified Public Accountant for fiscal year 2015-2016

Mr., introduced himself. Internal control, stated they are available every day. Stated the credentials of their Accountants, forty years' experience. They have worked with Mission ISD, Rio Grande City ISD, La Joya ISD, Weslaco ISD, IDEA Academy. Five are currently still with their agency. Mr. Garza was not available today.

2. Presentation by Pattillo, Brown & Hill, LLP, Certified Public Accountant for fiscal year 2015-2016

Ms. Lizzete Alafa, introduced herself to the Board. She works in the Brownsville office with partner Carlos Pecero she stated overall they have ten CPAs in there office. They do audits for Waco ISD, Houston ISD, San Antonio ISD and Albuquerque, New Mexico. The Brownsville office has several local school districts: BISD, Hidalgo ISD, Valley View ISD, Progresso ISD, Raymondville ISD, Lyford ISD, Rio Hondo ISD, Mercedes ISD, South Texas ISD. Along with some colleges, such as STC and Victoria College.

Ms. De la Rosa asked, since they do so many schools, do they complete the audits on time. Ms. Alafa stated yes. They've always submitted on time.

Mr. Rivera asked if all school districts audits are due at the same time or who sets the dates.

Ms. Alafa stated it depends on when the school year ends.

One of the tasks we do is preliminary planning; two to four people will come in and review the books sometime in September/October to kind of get started before they come in for the field work. We issue a management letter at the end of the year with recommendations to improve the school district.

3. Presentation by Luis C. Orozco, Certified Public Accountant for fiscal year 2015-2016

Mr. Luis Orozco, introduced himself. Has done school audits. He previously worked with Santa Maria ISD.

Ms. De la Rosa asked if he has ever been late with any of his audits.

Mr. Orozco stated when it comes to school districts, no.

Ms. Ortiz asked what other school districts he is working with right now.

Mr. Orozco stated, for the past three years he has only worked with Edinburg CISD.

Ms. De la Rosa asked if that's the only one he has ever worked with.

Mr. Orozco stated he has worked with Donna ISD, Weslaco ISD, and South Texas ISD in the past.

Ms. De la Rosa asked since he only has a staff of two or three employees, does he foresee a problem on being on time with our audit.

Mr. Orozco stated, he also has a gentleman that helps him. Mr. Roberto Lopez from Harlingen, Tx.

4. Presentation by Long Chilton, LLP Certified Public Accountants for fiscal year 2015-2016

Mr. David Segovia introduced himself on behalf of Long Chilton. Plenty of experience with school districts audits. They have worked with many districts in the valley. They have three offices here in the valley McAllen, Brownsville and Harlingen. They have over one hundred employees or there about and ten partners who have many years' experience. McAllen where he is from has thirteen CPAs. Currently they audit McAllen ISD, Harlingen ISD, Mission ISD, Sharyland ISD, Edcouch Elsa ISD and South Texas College. For a district size of Santa Maria ISD they will probably assign two to three people to work for us. Mr. Hinojosa asked if we have any questions will we be able to communicate with him. He stated yes, we will communicate with him or one of his staff and that should not be a problem. He also asked if a decision will be done today.

Ms. De la Rosa stated yes, they will be making a decision today.
