SUPERINTENDENT'S REPORT

Ms. Chavez stated the administration has scheduled a walk-through of the 5th Grade Building.

Board President asked for a motion to deviate from the agenda.

- 1. Presentation update of TGE 5th Grade Wing by Mr. Armando Martinez, Project Manager, for M-5 Texas Enterprise, LLC and Mr. Daniel Gonzalez, Project Superintendent
 - Mr. Daniel Gonzalez started the presentation by stating right now on the project is about 64% completed. We should have the project ready by the end of the month.
 - Ms. Chavez asked what the major activities you have scheduled this week are.
 - Mr. Gonzalez replied this week we will finish doing the electrical and the drywall in the building.
 - Ms. Chavez stated your communication to the board that you are more or less scheduled to pour sidewalks and canopy.
 - Mr. Gonzalez replied yes we will have delivery of all the canopy and steel that we need for the sidewalks and we are scheduled to pour next week.
- 2. Fulcrum Architect Services Report for 5th Grade Building by Mr. George Lazaro Mr. George Lazaro from Fulcrum Consulting Services started his presentation by stating we completed a construction analysis as to where we as architects are at this point and we concur with M-5 Enterprises analysis that were approximately 64% complete on the building. At this time there we are rough end stages of the inside of the building and after this week when the inspections get done M-5 will continue with the micro finishing of the building. We will continue working with M-5. Ms. Chavez, Superintendent, and staff that have been assigned to the project to make sure we provide the necessary ends that are needed from our firm in order to ensure that the project continues to move forward. As we progress and as other needs come up, we will go ahead and provide you a revised completion percentage of where we are on the project. That's my report for tonight unless anyone has any questions.

Ms. Chavez stated to add to your report the administration sent communication to Mr. Lazaro because of the closing out on project management at the end of February and based on my meeting with my contractor the insistence of the contractor of having 112 days of bad weather days and I have asked official communication from Mr. Lazaro to give me verification of those days simply because on that communication I had verified ten and a half days and I want to





make sure that we credit the contractor for all of the days that they are due on bad weather conditions and that I'm able to also secure the documentation that I need to be able to provide to legal on this. So that communication went out today on your packet you have a copy of that email that has expressed the concern and the questions that I have provided on behalf of the verification of those days per the administration.

Mr. Lazaro stated in our office we have already commenced getting that documentation and we anticipate having it at your office by the end of the week.

3. Student/Attendance Enrollment

Ms. Chavez stated the administration reports a total of 707 overall enrollment. An overall attendance of 96.9% for this past week with 352 students at the elementary level with an overall attendance of 96.95% and daily attendance for this past week was at 96.55% with 151 students enrolled. 200 students enrolled at the high school level with an overall attendance for the high school and you have that information there with a 96.9%.


