

Report from Financial Advisor on Tax Rate Increase/Homestead Exemption Increase on Homeowners' Tax
Obligations for 2016-2018 and 2018-2019 forward, Dr. Miguel De Los Santos, Estrada-Hinojosa Investment
Bankers.

Mr. De Los Santos stated you have an item on the agenda calling an order for election. I have analyzed the numbers a couple of times for you and finally Ms. Chavez informed me that the Board felt like they wanted to go out for the maximum which was about \$9,410,000 and so I ran the information all kinds of ways and you are in a good position right now because of the \$10,000 increment in the home set exemption that's coming in after we talked about that the last time. I had not analyzed the numbers for you at that time. Today I have a major item that we will be bringing to the community in terms of trying to help them understand that in fact for anyone whose house is valued at under \$60,000 will not pay any additional taxes for borrowing this money. For one whose house is valued at \$100,000, for three years they would pay \$136 a year and after that, actually from what they are paying this year, it would be going down \$35. What the community needs to understand is that you are in a position to borrow a substantial amount of money for very little to no impact on the regular homeowners. This particular year that we are in right now, the homestead exemption, anyone who owns a home and files a homestead exemption gets a \$15,000 reduction from their home value. Your tax rate for this year a \$1.30 cents, but starting next year for the next two year (2016-2018) your homestead exemption goes up to \$25,000. What that means is that whatever the value of you home is, you deduct \$25,000 and you're not going to be taxed on that. If you pass the bond election, next year your tax rate is growing substantially by 35.53 cents to \$1.6553 cents. The following year because the EDA state program will kick in and your taxes would go down and your tax rate would go down to \$1.4254 so if you look at those three lines, those three lines are going to impact what I'm going to talk about in terms of actual costs to the tax payer. The first column in the table itself lists home values. I think the average home value in this area is \$30,000. On the second column is this year 2015-2016. Right underneath it I have the tax rate at \$1.30 cents and the homestead exemption is \$15,000. This year when those who own property in Santa Maria went to pay their property taxes, the homeowner of a \$30,000 house paid \$195.00 in school taxes. For a person with a \$75,000 home, that person after their \$10,000-\$15,000 exemption pays \$780.00. Between 2016-2018 there are two changes that happen, your tax rate if your bond election happens goes up to \$1.65.53. Your homestead exemption goes up to \$25,000 so the person that owns a home that's \$30,000 actually pays on \$15,000 last year for this year. Next year they will be paying only \$5,000 of value. So the taxes from a person that owns a \$30,000 home would be less. They would only pay \$82.77. Next year which actually \$112.23 less than what they paid this year and that is with the district incurring \$9,000,000 plus dollars' worth of debt. When you get to the \$75,000 range anywhere you see those red numbers, those individuals are actually paying a little bit more than what they paid the year before. \$75,000 is paying \$47.00 a year more. \$90,000 is paying \$100.00 a year more and \$100,000 \$136.00 a year more and \$150,000 is paying \$314.00 a year more. That's only for two years because on the fourth column where I have 2018 forward, the tax rate drops to \$1.42. The homestead exemption pays the same at \$25,000 and the actual payments for each of these homeowners that year, all those in green are actually paying less than they are paying this year. Only the person that owns \$150,000 home is actually paying more than they paid this year. All of the homeowners \$100,000 are actually paying less than what they paid last year. The last column that's there is a net increase or decrease in taxes paid from 2015-2016 thru 2018 forward. You will be borrowing

\$9,410,000 through your high school project. Each person that owns a \$30,000 home from 2018 forward will actually be paying \$23.00 less than they paid this year. A person that owns a \$40,000 home will pay \$111.00 less than they paid this year. A person that owns a \$60,000 home will pay \$86.11 less than they paid this year. All these all the way to \$100,000 will be paying less. So the numbers in terms are very favorable, it a good time and what really is helping you in terms of the community understanding that your borrowing a lot of money, your building a high school and yet your taxes are going to go up only if you have homes that are at very high value. If homestead exemption that just kicked in that the legislature passed, it's balancing up. The increase in taxes is being balanced out by the exemption in the value of homes that you have to pay. In the next couple of weeks I will be working closer with Ms. Chavez and administration to develop a brief power point presentation so that you can get it to all community members and show how it is going to be paid for, how much it's going to cost them, and the main interest that people have after it's all said and done is what are getting for it and you'll be getting a brand new high school and how much is it going to cost us and how are going to pay for it and this is how it's going to be paid.

2. Presentation update of TGE 5th Grade Wing by Mr. George Lazaro, Fulcrum Consulting Services. Mr. Lazaro stated tonight I would like to report that the contractor M-5 Enterprises continues to work aggressively towards the goal of finishing the building. Fulcrum Consulting Services and Ms. Chavez continue meeting with the contractor twice a week to get status reports as to what is being planned and what is being completed. As of today all the brick masonry for that building has been completed. All the steel has bed erected. Necessary inspections have cleared for the steel. That was sent to our office this afternoon. Their intent is to move forward with covering up the roofing system. Additionally on the inside they have commenced and completed all the steel framing to separate the particians for each classroom. They commenced working on the electrical for that facility. They have the doors and windows in line for instillation this week. As soon as they get the material on the roof system, they are going to commence working on the plumbing and ac systems but they need to have the building secured in order to prevent from somebody potentially taking that equipment once they start instillation. As of today, they have about two weeks to really come together with that building. We have expressed to them that we will continue meeting with them on a timely basis and we will continue pushing for them to try to have the completed project.

3. Student/Attendance Enrollment

Ms. Chavez stated I want to thank the school administration and the staff at the high school level as well as the middle school and elementary school for working very closely with all of their staff to make school attendance a priority. At the elementary we closed with 352 students with an overall attendance of 97.03%. At the middle school we closed with 150 students enrolled with an overall attendance of 96.4% and at the high school 201 students enrolled and attendance at 97.5%. Overall district attendance is at 97.02 and at this time I would like to thank all parents for making school a priority.
