## 1. Presentation by George McShane, Educational Consultant

Mr. McShane introduced himself. Presentation of Team Building, Goal Setting and Evaluation of Board and Superintendent.

The Team of eight. Three continuous credit hours, level two, this will satisfy the requirements of having your team built. We will talk about who we are as a board. Communication between teachers, parent and students. Change, transformation from No child left behind established in 2002 under President George W. Bush to Every Student Succeeds Act put in place by President Obama. That means we no longer have to deal with AYP. We're going to see more state and local control. We are going to see a consolidation of some fifty programs into one. This will bring more grants for special needs students.

We need to get back in to the classroom and the quality of the experience. The process of accountability. From the perspective of where we are in the district, and working with many of our recent immigrant students. The fact that there could be a program that is much more in reaching to the acquisition of the second level. But rather the isolation of parent students for assessment, address the academic English that the students need to be developing. And we tend to have and serve that population in our community, at least three fourths of our students at the elementary level coming in.

Mr. McShane asked the board members to introduce themselves and how long they have been on the board.

Miguel Zavala has been on the board for five years. And has children in our district.

Oralia Ortiz has been on the board for one year and enjoying it.

Belinda Lugo has been on the board for four years. She has two children in the district.

Noe Aleman has been on the board for nine years. He has two children in the district.

Consuelo De la Rosa was on the board for about 18 years then came back going on one year. Has a grandchild in the district.

Adolfo Hinojosa has been on the board for three years no children in the district but has a brother in the district.

Alyssa Romero district attorney is from Brownsville married and her husband is a teacher with the Edinburg CISD.

We will talk about seven goals for the district.

Head start program started by President Lyndon B. Johnson. And we didn't have a system it was more like a daycare. Now we have educators with expertise to teach the kids. Working in collaboration with other districts. Harlingen got started with the Pre K. Implementing the Circles curriculum with Ms. Carmen Alvarez to help students. Giving our children opportunities they are bright.

THE FOUR C: Communication, Collaboration, Critical thinking, and Creativity.

Middle School grades six, seven and eighth, High School and Early College, our students are taking college classes as early as the middle school, eighth grade.

If you can inspire students they will likely do better, teachers working together and it works.

How ready are the board for the change, about eight to ten, the teachers are at about a four and as a school district we are at around a six, six and a half.


The staff at the high school is probably at an eight. Need to get them college ready but we need to get the staff to be able to get to a ten. In order to get our students college ready it starts in the beginning. Teachers and counselors need to know what the students need to qualify for the financial assistance and parents need to know.

Make sure you make a difference as a board member, make sure that trust factor is there within the district, we have to believe in our school district provide incentives to our teachers.

Superintendent Evaluation, you look at the goals as a board and you see the performances of teachers at the campuses in the district. Where are we now? Where is our district going? Student enrollment. Look at stipends and salaries, if needed to increase to keep your staff from leaving to bigger districts. Take care of your leadership.
