classmates. Valley Baptist Preparatory which I represent meets at Primera Iglesia Bautista about three blocks east of here. Both Valley Baptist Preparatory and the Santa Maria School have begun the final grading period in this first semester. We are all looking forward in achieving the goals that we have set for this semester. At Valley Baptist Preparatory we can support you in those goals for your students. Right now were working all day every day on English as a second language with one local middle school student and preparing him to transition back to you. Mrs. Rodriguez and Ms. Quintero know that the student will be enrolling in Santa Maria Middle School soon. I have met with the Math, Science, English and Social Studies teachers and I want you to know that they have been very helpful getting this student ready to come back. I propose that you allow teachers in grades 5th-11th to identify the students that are doing poorly perhaps because of their lack of success in English. Those teachers might list the students that they would for me to teach basic or intermediate ESL to and then the principals would approve or modify the list and we could agree on a total program which would run for one semester although the student could come for one, two or three grading periods. Valley Baptist Preparatory provides experienced teachers, provides the Rosetta Stone in the Language Laboratory, provides small classes, internet and a library with over 600 books. The price per student, we would talk about. The Santa Maria District would provide some of the text books and I would provide some of the text books. If you want the students to also be prepared for the grades in a specific subject that you would like for them to get at the end of a specific semester, then I would work with you on those text books and work books, otherwise we would focus more on ESL. As far as daily attendance is concerned we would call to the school each morning and afternoon so that we could tell you about the absences and that would therefore take care of your federal funding. We would talk about breakfast and lunches and about transportation and any other questions that you might have, I'll be happy to work with you. Let's get these students ready for their state tests and for a successful school year.

SUPERINTENDENT'S REPORT

1. Presentation update of TGE 5th Grade wing by Mr. George Lazaro, Fulcrum Consulting Services.

Mr. Noe Esquierdo introduced himself and stated I'm part of the management team for fulcrum consulting. George Lazaro could not be here today so I will be conducting the presentation for him. Basically up to date, we are at 50% as far as construction completion. This week the contractors anticipate the final steel columns to be delivered to the site as well as the brick veneer for the exterior. The interior block is 100% completion and as far as the contractor is concerned, he is on track to finish at the date that he's anticipated. If he does think that he's going to need any extra days, he will submit that proposal to us and we will review it and if we think it's within his contract, we will present it to the board if needed. That's basically the presentation on the 5th grade wing update.

Mrs. De la Rosa asked if we are on schedule for completion.

Mr. Esquierdo stated yes, right now the date for completion is the 8th of January but there have been some days where it's been raining so they may be able to ask for those days. As of today, they haven't asked for any so they are telling us that they think they will be able to finish by that date. That's what they are trying to push for. If they do need extra days, they do need to let us know ahead of time and we will present it to the board.


