Facility Committee Meeting

Update on 5th Grade Building Project
 Superintendent introduced Mr. George Lazaro, Senior Engineer with Fulcrum and District Engineer.
 Mr. Lazaro stated that despite the weather we've been having the contractor has been trying to do the best job that he can. But just this month twelve rain days is what's been officially recorded. This morning during our early morning meeting, one of the things we emphasized was that he needs to take advantage of this good weather, because the thirty day forecast for the weather in the Rio Grande Valley shows that he may have another fifteen days of rain. So he needs to capitalize on that and do as much as he can so

he can complete his walls, the structure steel has already been ordered so he can go ahead and put in his roofing so once he does that, he can start working on the inside rain or shine. He understands the importance of doing that. One of the questions I asked right now is why isn't he working if it's a good day? He gave an appropriate answer, right now he is in the stages where the inspector needs to come by and do an inspection on the wall beams. Which they came by today and it passed. So hopefully by tomorrow morning he his crews to keep on moving forward. There are some things that need to be taken into consideration tonight and one of them is the air conditioning systems.

- Presentation on HVAC System- the original system that was provided as part of our specifications included a unit which we call ERV (Energy Reserved Ventilation) unit and the purpose of that unit is that it serves two purposes. During the summer, when we have high humidity and hot air before the air goes into the ac unit and gets treated to circulate into the classrooms. It turns the hot air a little cooler and removes the humidity from the air to make it more efficient. And during the winter its reversed, you have less humidity in the air so it introduces a little humidity and it warms up the air.
 - The reason for those units is not an assurance but, it helps to prevent mold issues in buildings and now it is being implemented by other schools. A lot of the issues that have happened is because it is a newer unit and some of the people don't understand the way that it should be serviced. Sometimes its out of view and in order to get to them you have to remove the tiles. School maintenance only change the filters. And these units have two filters that have to be changed anywhere from thirty to sixty days. Depending on the air quality that they are treating and there has been instances where they have failed. So maintenance is a big part of this. Because of the concerns that have come up, we have worked with the contractor to give us a price for deducting these units. They are not needed but it's a recommended safeguard by Ashray. And he's giving us a pretty good deduct. These units run about a thousand dollars a piece. There are five units being purposed for the fifth grade building, basically one for every major classroom, lab and the big walk through corridors. He is giving us a three thousand dollar deduct that includes the cost of the unit, it involves the labor, plus the connection including duct work and the electrical work that comes part of it. We are making the recommendation that you all consider approving this change order at the appropriate time. And what that will allow us to do, is that right now the contractor submitting submittals to us, showing what he is planning to install but without having this change order approved or not approved, we can't approve those material submittals. So after you take the necessary actions then at that time, if should you all decide to remove those units and get the \$15,000 credit, his submittals are tattered toward that at that time but if the board should decide to leave them the way it is the he is gonna have to come back and revise his submittals to make sure that those energy recovery units are there. But that's one item that needs to probably take place tonight. Once they start doing the covered area, five hundred square feet, they can very easily do it in a very short amount of time. And the next thing is that they start working on all the electrical components, mechanical components and of course the ac components. At this time the contractor is concerned, he is saying Mr. Architect you haven't approved them. We are also getting to the stage of the project to where, colors need to be picked. Joey will be doing a presentation on flooring, toning, color, laboratory counter and counter tops. Hopefully we can come up with a decision tonight or if you need to think about it, maybe we can come to another meeting.
- Presentation on Color Scheme —
 Joey Yzaguirre stated more of the details come with the interior design of the building. As an interior designer, I can choose the colors for you but, overall it's better for you all to decide.
 A board sample of the colored tiles was requested by the board of trustees, so they can see how the colors blend together
