SUPERINTENDENT'S REPORT

2. Update on District Status of TGE 5th Grade Wing: Presented by Fulcrum Consulting Services Mr. George Lazaro, Senior Project Engineer

Mr. George Lazaro, Senior Project Engineer opens presentation by introducing Mr. Joey Izaguirre, Junior Architect dedicating his full time efforts to working on the Projects for Santa Maria ISD, Mr. Kurt Morton, Lead Architect for this Project unable to be present today.

New drawings presented for the new Elementary School addition. Started off with picture/rendering that shows you how the proposed facility will look like. This proposed facility will be located on the North/West corner of your existing High School parking lot, vacant area. Mr. Rambaldo "Ram" Rivera, Jr. and Ms. Belinda Lugo requested that Mr. George Lazaro turnaround to face and be able to present to the public audience too with picture/rendering. The rendering for the school is actually a 5100 square foot facility addition that will be done. It will represent the type of architectural that will merry into the design of the high school with the school colors being elaborated along with the designated rendering colors and different lines that will be followed for the building. It is going to be a building that is going to be a state of the art. We have had several meetings over the last couple of months in order to try to narrow down the educational program and goals that the school district is attempting to accomplish by this project. Right now your facility it is lacking an adequate laboratory science facility. The one that is going to be in place is going to be one that is going to be state of art and that is going to comply with all TEA requirements. Basically the layout of this addition will have a science lab, three adequately sized classrooms along with restroom facilities and an assembly room to be able to gather students and faculty for different types of activities. At this time plans and specifications for this project are about 95% complete and our firm is ready to go out and solicit bids for the project. The only item that will be necessary for us to bring to the board in the month of January is that Texas Law requires us that the board officially approves the educational plan for this facility. Ms. Chavez has done a great job in working with us to try to elaborate that multi page document, I think we have it all ironed out now. You then have to officially give us the permission to go out and solicit bids. This is going to be a state of art classroom facility that is going to make the school district very proud and offer the children that will be attending the greatest educational opportunities in South Texas. Mr. Noe Aleman inquires if this presentation is only for the Elementary portion. Mr. Lazaro clarifies that this presentation is just for the Elementary portion at this time.

Superintendent of Schools, Maria J. Chavez adds that this is the additional classroom space for 5th grade and looking at currently the science is tested at the 5th grade level. This content is being taught in a regular classroom, so we are proposing a complete compliant outfitted Science Lab for 5th grade. This is also giving us the opportunity to also have a multi-purpose meeting space in this case. Currently if we have any types of meetings the only options that we have are the cafeteria, the gyms and the libraries. We want to move away from shutting down libraries, so that we can conduct any of our professional development meetings or any of the necessary testing orientation for staff and for students as well. This is



one of the areas that we were looking at the limited space capacity that we currently have at the elementary school and outfitting a space that would be more in compliance with the curriculum for the 5th grade, grade level.

Ms. Consuelo De La Rosa says this is all good, but my question to you is did the Building Committee meet to design this buildings or who is designing or who is picking up the design? Has the board met and said this is what we want?

Superintendent of Schools, Maria J. Chavez responds by saying this is one of the discussions that we put through the Building Committee in terms of the facility needs at the elementary school. The initial phase of that project, the presentation that the committee received was the initial review of the existing portables or the buildings that we have in the mall area of Tony Gonzalez Elementary to be able to look at the roof and what it would take to be able to renovate that space and then to able to convert one of the spaces for a science lab. When we came back and looked at the cost of the renovation project and the fact that we were land locked in that space then we looked at what would be most cost efficient and actually gives us the amount of space that we need. Once we began looking at the actual space within those two rooms to be able to tag a science lab then we were already moving into the instructional space we have for the high school in this case. This was one of the options that came out, but we were still one classroom short in this case, because if we converted one to a lab or we added an additional lab it would only give us two instructional spaces and one lab. This came about in terms of the most cost efficient and looking at materials and a design that would mural or blend in with the existing facility at Tony Gonzalez Elementary.

Mr. George Lazaro added that this would also blend with the future facade of the new high school too.

Superintendent of Schools, Maria J. Chavez continues to say that the other area that is being looked at very closely right now with the 5th grade for the parents who are here. The state has already removed the second assessment in the area of math. Student now at the 5th grade level will have one administration of that assessment at the 5th grade level to be promoted to the next level and the same applies to the 8th grade level. Science is tested at the 5th grade level and is tested again at the 8th grade level. The options we had as a school district to retest students three times in the areas of math and reading those options are not going to be available as of this year. It will be the first administration. We know that the facilities impact the instructional process and the curriculum that is ultimately gets taught at the elementary level. If we want our students to be college ready it is important for us to begin looking at the type of instructional facilities and the type of curriculum we are delivering in terms of the instruments the students have to use. In the science curriculum there are approximately twenty eight instruments that the students must not only learn the name, but the application of that instrument. If were teaching science in a regular classroom it is very difficult for a student to assimilate a lab and to show up for that exam and to assume that you have been conducting that level of instructional labs in the classroom.

3. Update on District Status of HS Project and USDA Award presented: Fulcrum Consulting Services Mr. George Lazaro, Senior Project Engineer

High School Project, no renderings tonight. Plans and Specifications are between 85-90% complete, near completion of full set of plans and specifications to be able to go out for bid. At this time all architectural



drawings and renderings done. Working on last minute coordination with some aspects to the structure ensure its integrity it deserves and finishing up in the mechanical, electrical and plumbing. All these aspects are handled internally within our office with the exception of the structure. In order for checks and balances we do have a structure engineer that work with us on that, going very smoothly. We anticipate that by the end of January we should have a full set of plans for that. Next stage for Santa Maria ISD Board and Superintendent of Schools is to continue working with the land owner for good negotiation that will benefit the district, so we can get in line to start working on this project.
