# EXECUTIVE SESSION AUTHORIZATION DURING MEETING

If during the course or the meeting covered by this notice the Board should determine that a closed or executive meeting or session of the Board should be held or is required, then such closed or executive or session as authorized by chapter 551 or the Texas Government Code, the Open Meeting Act, will be held by the Board at the date, hour, and place given in this notice, as the Board may conveniently meet in such closed or executive session concerning any and all subjects and for any and all purposes permitted by Section 551.071 through Section 551.084 inclusive of said Open Meeting Act including, but not limited to:

Section 551.071	For the purpose of a private consultation with the Board's Attorney or any or all subjects or matters authorized;
Section 551.072	For the purpose of discussing the purchase, exchange, lease or value of property;
Section 551.073	For the purpose of discussing negotiated contracts for prospective gifts or donations;
Section 551.074	For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee;
Section 551.075	For the purpose of conferences with staff to receive information from staff, or to ask questions of staff, without discussion between or among Board Members.
Section 551.076	For the purpose of considering the deployment, specific occasions for, or implementation of, security personnel or devices.
Section 551.082	For the purpose of considering discipline of a public school child, or complaint or charge against personnel.
Section 551.083	For the purpose of considering the standards, guidelines, terms, or conditions the Board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.

Section 551.084 For the purpose of considering excluding witnesses from a hearing.

Should any final action, final decision or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive session, then such final action, final decision or final vote shall be at either:

- a. the open meeting covered by this notice upon the reconvening of this public meeting, or;
- b. at a subsequent public meeting of the Board upon notice thereof, as the Board shall determine.
