The Washington County High School will:

Washington County High School offers the standard curriculum of the Alabama State Board of Education. Students that have achieved a minimum of 19 on the ACT are offered Dual Enrollment within Junior & Senior English and Senior Mathematics for the purpose of attaining college credit through the Alabama Southern Community College. Students are afforded Career Technical opportunities on campus, as well as the Washington County Career Technical Center. All teachers at WCHS are Highly Qualified in their respective discipline. Research-Based Instructional Strategies are implemented in every classroom. Data from assessments are reviewed and interpreted for the purpose of driving instruction.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

Parent-teacher conferences can be held at any time. Parents/guardians will need to either email the teacher to set up an appointment or call the office (251-847-2851) to make arrangements. A meeting will be held on virtually if parents/guardians have any questions concerning the compact.

**3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

Students will receive progress reports every four weeks and a report card every nine weeks. Parents also can access student grades through Home Portal which is available through the district website. (wcbek12.org). Login information can be obtained through the school counselors.

Faculty can be reached directly through email. Parents/guardians can also call the office to set-up an appointment time to meet with the teacher directly. Teachers are only able to meet on planning time during school hours.
