Private Non-Profit Public Notice of Equitable Services

Hardin-Jefferson ISD is preparing to apply for federal funds under the Elementary and Secondary Education Act. Therefore, we are required under Section 1117 and Section 8501 to have a timely and meaningful consultation with private non-profit (PNP) school officials. Such consultation must occur before any decision being made that affects the opportunities for eligible private school students or teachers to participate in programs. A private non-profit is eligible to participate only if it can provide documentation of 501(c)(3) nonprofit status and the students meet program eligibility.
