Personnel expense

- Plug in our data against neighboring schools to see how our contracts and related costs compare to that of neighboring schools
- Duplicate Madeira Work
- Summary of key points across districts (ex. Starting salary, etc.)
- How many are within 5 year so retirement for a potential buy outstrategy
- Benefits analysis (ex. Medicare at 1.5%, etc.)
- Team work to provide recommendations and observations from data
- o Income Tax What is the revenue potential? What are surrounding districts doing?
 - o Earned income tax vs. income tax options
 - Same structure/registration as that of property tax
