Section 1. That the Auditor and the Treasurer of Hamilton County in accordance with Ohio Revised Code 321.34, be requested to draw and pay to the Loveland City School District upon the written request of the Treasurer/CFO, Brett Griffith or Lindsey Masse, to the County Auditor, funds due in any settlement of 2016 derived from taxes or other sources, payable to the County Treasurer to the account of the Loveland City School District, and lawfully applicable for purposes of the current fiscal year of 2016 (July 1, 2015 to June 30, 2016) and for the concurrent fiscal year of 2017 (July 1, 2016 to June 30, 2017).

RESOLUTION NO. 16-09 APPROVE THE FOLLOWING RESOLUTIONS

Ms. Pettit moved, seconded by Dr. Lorenz to approve the following resolutions:

- Set Board member compensation at the maximum allowable by law.
- Authorize the Superintendent of the Loveland City School district to apply for available State and Federal Funds/Grants
- Authorize the Treasurer to submit membership of the Loveland Board of Education with NSBA, OSBA, OSBA Legal Assistance Fund, and the Alliance for Adequate School Funding.
- Establish a service fund not to exceed the maximum allowed by law for the Loveland City Board of Education as authorized by Ohio Revised Code Section 3313.15.
- Appoint the Business Manager of the Loveland City Schools as purchasing agent for the Loveland City School
 District and to direct the Superintendent to use a system which will insure the quality of purchases in an efficient
 manner for the operation of the school district.
- Set surety bonds for the Treasurer and Business Manager at \$100,000 each and for the Board President and Superintendent at \$50,000 each.
- Authorize the Treasurer of the Loveland City Board of Education to establish new fund accounts and to establish new accounts with financial institutions, when applicable, for the Calendar Year 2016.
- Establish the School District Records Commission comprised of the Board of Education President, the Treasurer of the Board of Education, and the Superintendent of Schools for the Calendar Year 2016. The Records Commission shall meet at least once every twelve months and establish rules for retention and disposal of records and for review of the same records.
- Approve the following firms to provide legal services to the Loveland City School District: Ennis Britton Co., L.P.A., Dinsmore & Shohl LLP, and Bricker and Eckler LLP.
- Authorize the Treasurer to pay all bills as they are presented, provided funds are available, and to report monthly to the Board of Education those bills that were paid.
- Authorize the Board President and Treasurer to borrow money for Loveland City School District as needed and allowed by law.
- Appoint the Superintendent as Chief Executive Officer of the Board of Education to conduct the Boards' business, as
 deemed necessary and in consultation with the Board, at times the Board is not in session. Any action is pursuant to
 approval by the Board of Education at the next regular board meeting.
- Authorize the Superintendent, on behalf of the Board, to accept resignations which have been submitted by
 employees during times the Board is not in session, subject to ratification by this Board; provided however, that
 upon ratification by the Board, such resignations shall be deemed effective as of the date and time of the
 Superintendent's acceptance. This authorization must be renewed at each year's organizational meeting.
- Authorize the Superintendent to employ necessary personnel on a temporary basis until such time as the Board of Education is able to take official action.
- Appoint Keith Koehne, Assistant Superintendent of Human Resources, and Amy Crouse, Assistant Superintendent of Teaching and Learning, as Loveland City School District Anti-Harassment Compliance Officers in accordance with the Board's Anti-Harassment Policies.
