- Cumulative Reviews - Teachers with non-EOC or non-CTE courses must give their cumulative reviews (worth 20% of total grade) to students on **Fri., May 17th** during their regular class periods.
- If a course is not an EOC or CTE, students are expected to take a teacher-made test if they have not met the exam exemption criteria.
- Senior Grades finalized by 1 p.m. on **Wednesday, May 22nd**.
- All Grades are due by 1 p.m. on **Friday, May 24th**.
- Bring a fully charged Chromebook each day to testing. Senior Students will turn their Chromebook & charger into the Media Center on their last day of testing.
- Any student on campus without an exam during the morning session will report to the cafeteria for a quiet study hall.
- Any student on campus during the afternoon session will report to their designated class for that period.
- Courses with EOC/CTE state exams: EOC: Biology, English 2, Math 1, & Math 3. CTE: Project Management I, Financial Planning I, Financial Planning II, Apparel I, Apparel II, Career Management, Health Science I, Business Essentials, Principles of Business, Horticulture I, Horticulture II, & Culinary I

- The testing coordinator and BLC will schedule seniors to have EOC and CTE exams completed by the end of the day on **Tues., May 21st**.
- ALL EOC and CTE exams for seniors must be completed by the end of the day on **Tues., May 21st**. (to allow time for grades to be processed prior to graduation practice).
- Online students enrolled in courses with state EOC/CTE exams must test in person at Bunker Hill and will be notified by the school. Students will be notified by their teachers as to when all other online classes are scheduled to test.
- Each student is expected to take his/her exam on the designated day unless the student is out due to an excused, unexpected illness or the Principal and/or Testing Coordinator has approved an exception.
- All students should be prepared to be available through **Fri., May 24th**. In recent years, both inclement weather and technical issues have forced us to revise the exam schedule. Students should not schedule vacations, appointments, etc. until after the official end of the semester.
- Students who plan to leave after the morning exam session is completed must bring a note signed by a parent or guardian **EACH day** in order to leave. Phone calls, faxes, or emails will not be accepted.
- **Teacher Cumulative Reviews (All other classes)** - All classes not classified as EOC or CTE classes do not have a state exam. Exams for these classes are made by the BHHS teacher.
