SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. Due to the pandemic and restrictions for gathering in place for non-vaccinated individuals, the district engaged in a Thought Exchange (\$24698) that targeted secondary students, parents and community members, and staff asking for considerations going forward into the next couple of years. These results were shared with the governing board and recommendations are found in this application. Thought Exchange, as well as focus meetings will take place to update parents on plan and gain insight into areas to be addressed/prioritized each year of the grant.

In order to safely operate school for in-person learning, an LPN was hired part-time on a per diem basis to assist in COVID testing, record keeping, contact tracing at a rate of \$16/hour for a 7 hour day and approximately 4 days per week depending on need (\$17,920).

Data utilized by the LEA to measure the effectiveness of the social worker include discipline data, attendance data, logs of parent outreach.

The LEA will use the funds reserved under section 2001 (e)(1) to address lost instructional time through extended day tutoring for grades 3-8 at a cost of \$81,000

The LEA extended the learning during the summer for K-12 students through OHM BOCES summer school with a cost of \$58,405. Secondary students were noted to be struggling in many core courses, due to issues comprehending text. A secondary reading teacher (\$45,061/yr) and a research-based reading program (\$10,500) are needed to allow students to find success throughout their academic program. The LEA replaced an English position with a reading teacher. *The Reading Teacher prepares students to interpret complex ideas, critically analyze arguments, synthesize information from multiple sources, and use reading to build on previous learning. This is done by teaching core skills, emphasizing content, and a focus on personalization.*

Science enrichment equipment through hands on robotics and STEM program to engage students in sciences and STEM opportunities (K-12) - \$23,771. *Hands-on, inquiry-based science instruction sees learning as a dynamic and social process (both missing during remote instruction) in which learners actively construct meaning from their experiences in connection with their prior understandings and the social setting. This is done in a way to teach perseverance and determination when faced with challenges. The problem-solving skills learned are multi-disciplinary and support the NYS Science and Mathematics Learning Standards.*

Funds will be used to fully fund a district-wide social worker (\$51,047/ yr) to continue to address social-emotional learning, parent outreach, and chronic attendance issues. Students have presented with a number of at risk behaviors that have manifested itself in acting out behaviors, attendance/truancy issues, vaping, etc. The social worker is a critical point of support as well as a case manager that oversees the ability for outside agencies to work with students and families.

Funds will be utilized to fully fund an elementary music position (\$54,792/yr) to provide music enrichment to meet the request for more fine arts offerings at the elementary level.

An ENL Teacher ((0.4 FTE at a cost of \$37,998/yr) through OHM BOCES will provide necessary instruction to meet the mandated instructional requirements of ENL students. In addition, the ENL teacher provides General Education teachers with strategies of different accommodations that can be used throughout the day to maximize the learning of all students, particularly ENL students.

In addition, as part of strategic planning, the district will be conducting a study to ascertain district goals and needs going forward. All stakeholder groups will be surveyed as part of the district survey. WNYESC will be conducting the survey (\$39,002). This, coupled with increased communication through webpage, app, and school messaging through use of Blackboard ((\$8920/yr) will provide frequent updates to parents and other stakeholders.

All students, regardless of income, race, ENL, special education, or homelessness, are offered and encouraged to participate in all programs offered at the LEA. Transportation, often seen as a barrier, is offered, allowing all students the opportunity to attend any before or after school program. An elementary counselor, the school nurse, the secondary school counselor, and the social worker, with the two principals, actively meet with teachers as a child study team to address the learning and social-emotional needs of students. The elementary counselor, the secondary school counselor, the social worker (\$51,047/yr) meet as a team to address the social, emotional, and mental health needs of all students, particularly children with disabilities, and any student experiencing trauma. The ENL teacher (\$37,998/yr) is also part of that team if an ENL student is struggling with academic or social and emotional issues.

The LEA has formed an advisory council of stakeholders representing-parents, administration, transportation, special education, and non-instructional staff that will meet quarterly to review the plan and make recommendations to the superintendent. In addition, the LEA will send a survey to all stakeholders every six months to ascertain needs and determine revisions needed. Public comment will be collected from Thought Exchange data, and through small group meetings such as PTSO and Sports Boosters.
