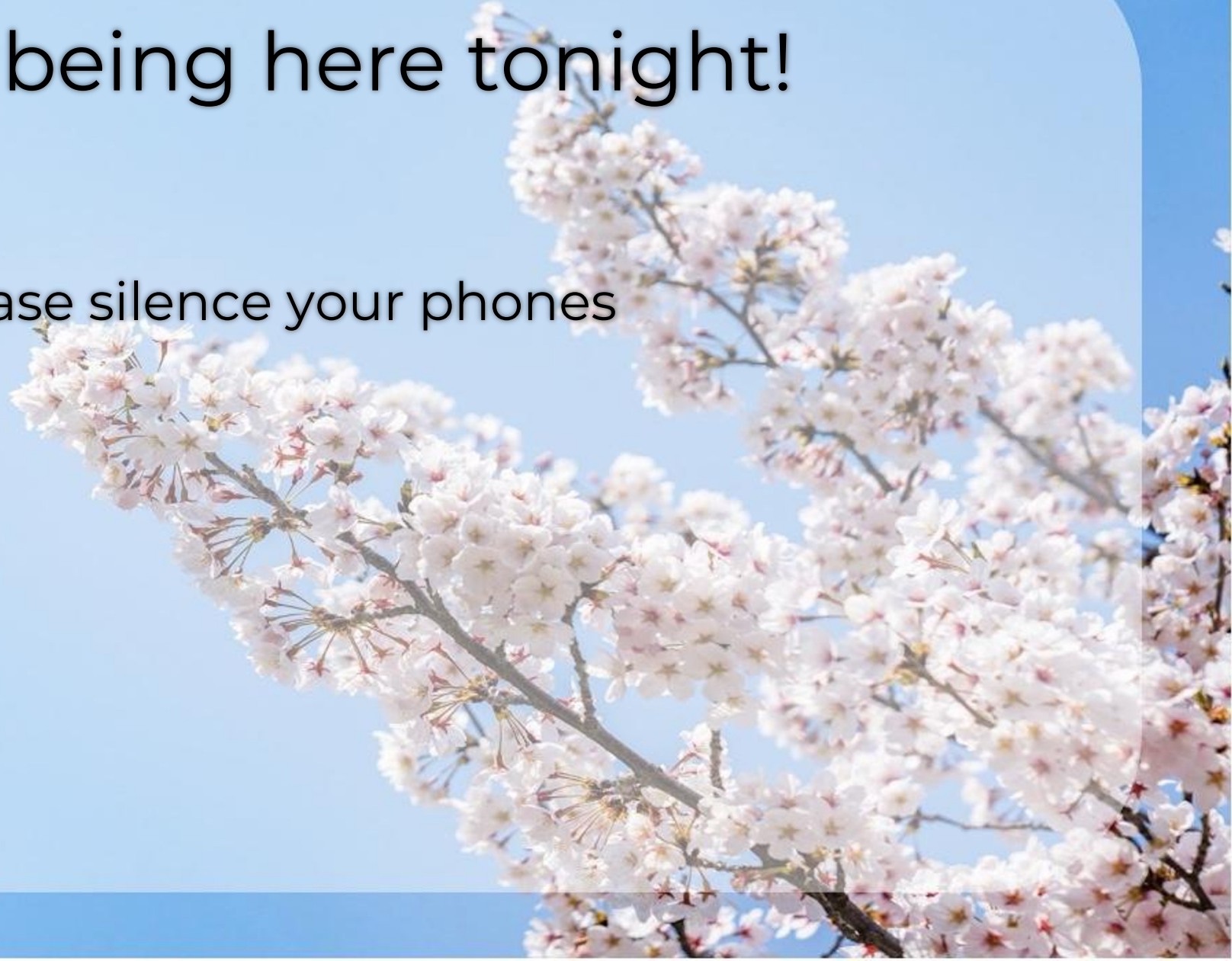

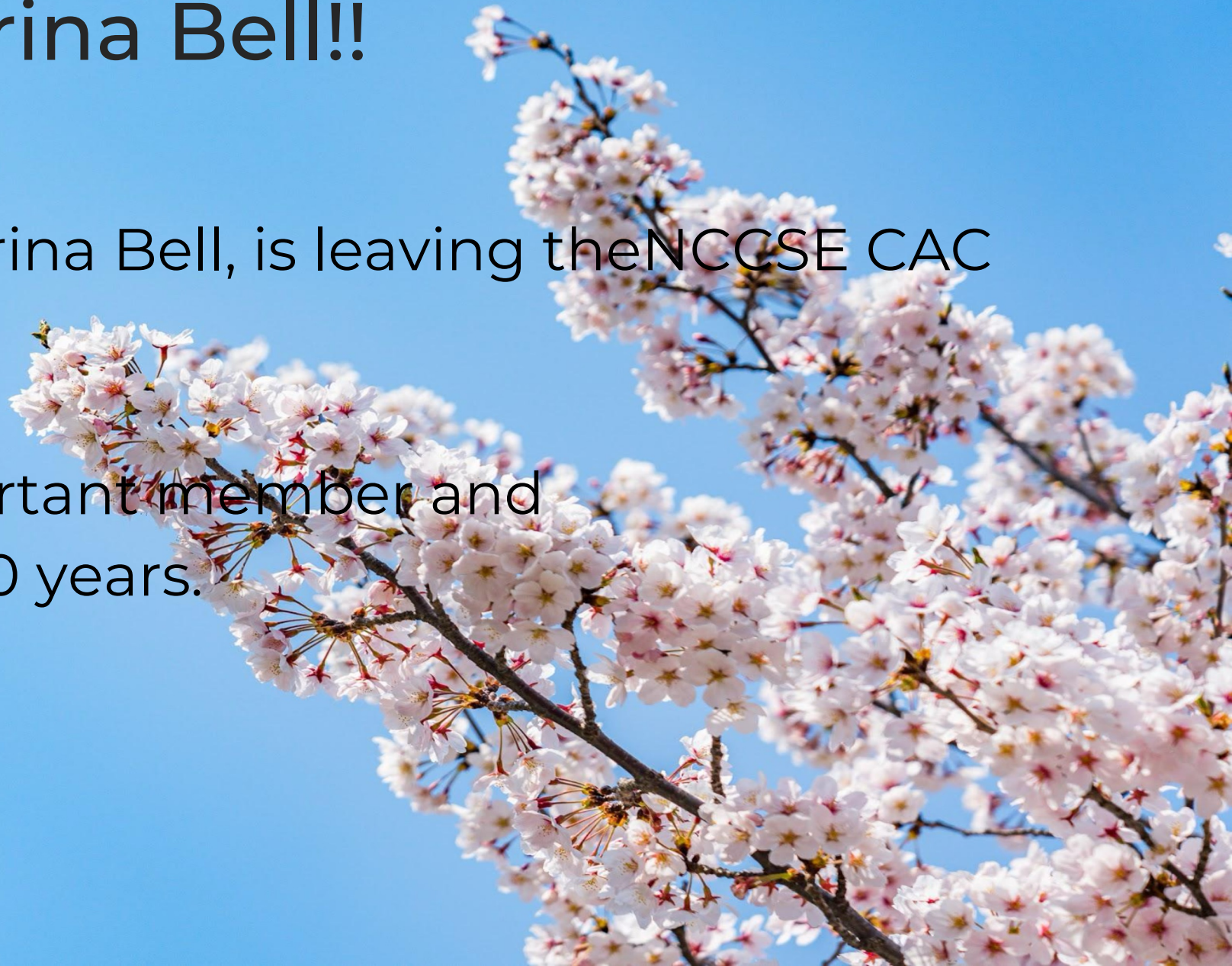

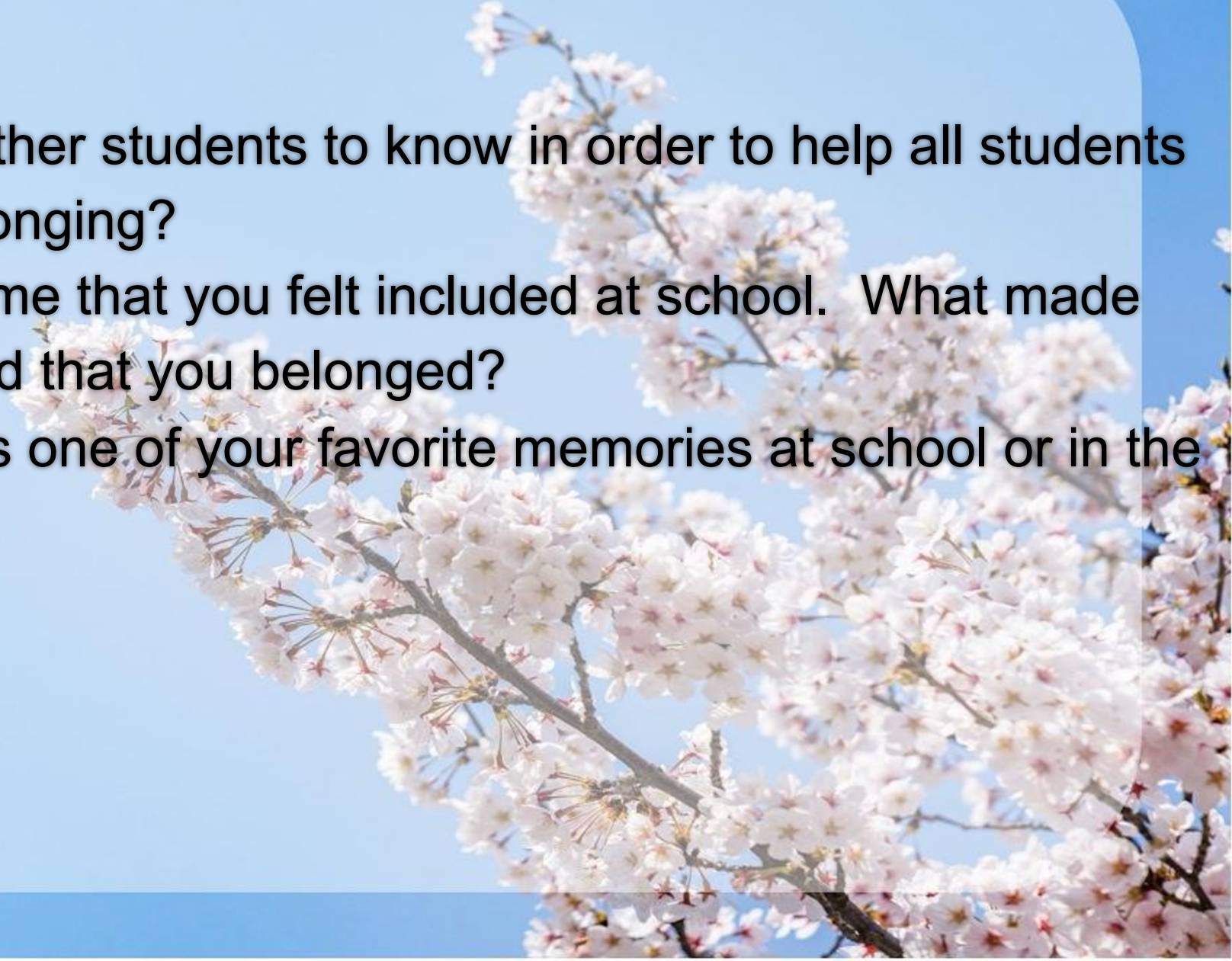


Presentation: Inclusion Panel Discussion
