Every Student Succeeds Act (ESSA)

The Every Student Succeeds Act (ESSA) is a US law passed in December 2015 that governs the United States K–12 public education policy. The law replaced its predecessor, the No Child Left Behind Act (NCLB), and modified but did not eliminate provisions relating to the periodic standardized tests given to students.

Every Student Succeeds ACT Highlights (ESSA)

- Holding all students to high academic standards
- Ensuring accountability and guaranteeing that when students fall behind, steps are taken to help them and their schools improve
- Continuing to ensure that parents and educators have annual assessment information about how students are doing
- Empowering state and local decision-makers to develop strong systems for school improvement
- Protecting students from low-income families by assuring they are taught by highly effective teachers

Complaint Procedures for Title I Part A

Grounds for a Complaint

Any individual, organization or agency may file a complaint with the Richland County School District One, if that individual, organization or agency believes and alleges that the RCSD1 is violating a Federal Statute or regulation that applies to a program under the Every Student Succeeds Act of 2015 (ESSA). The complaint must allege a violation that occurred not more than one (1) year prior to the date that the complaint is received, unless a longer period is reasonable due to an ongoing violation.

Edit Page

Filling a Complaint

Complaints and grievances shall be handled and resolved as close to their origin as possible and through the proper channels using the following procedures:

A complaint must be made in writing and signed by the compliant. The complaint must include the following:

- A statement that the RCSD1 has violated a requirement of a Federal stature or regulation that applies to an applicable pro-gram;
- A date on which the violation occurred;
- · The facts on which the statement is based and the specific requirement allegedly violated;
- A list of the names and telephone numbers of individuals who can provide additional information;
- Whether a compliant has been filed with any other government agency, and if so, which agency;
- Copies of all applicable documents supporting the complainant's position; and the address of the complainant.

Academic Assessments

- Prekindergarten- Individual Growth & Development Indicators (myIGDIs)
 - myIGDIs helps assess the development of early literacy, early numeracy, and social-emotional skills needed for kindergarten while they're still in preschool.
- Kindergarten Kindergarten Readiness Assessment
 - Provides a snapshot of students' abilities at the beginning of the school year and measures school readiness across multiple domains: Social Foundations, Language/Literacy, Mathematics, and Physical Well-Being.
- Kindergarten through Fifth Grade Benchmark Assessment System (BAS)
 - Determines student's independent and instructional reading levels and progress along a gradient of text levels over time.
- First through Fifth Grade Star Reading and Math
 - Scaled scores used for comparing your child's performance over time and across grades.

Academic Assessments

- Third through Fifth Grade SC Ready (Reading and Math)
 - Measures the SC College and Career Readiness Standards taught in ELA and Math classes. Statewide assessment administered to students in grades 3–8 as required by the Education Accountability Act.
 - •Fourth Grade SC PASS (Science)
 - Statewide assessment administered to students in elementary and middle school as required by the Education Accountability Act
