SUPERINTENDENT'S REPORT

LEGISLATIVE REPORT

Ms. Haywood, Montgomery County Legislative Committee Representative, reported they discussed the following at the last meeting: We can expect challenges for public education at the state and federal level in the coming year. At the federal level; we can expect the incoming Administration to increase school choice and privatize education as some of its primary goals. At the state level; the structural deficit that will negatively impact any additional funding for public education. Regarding the 2017-18 school-year, school districts should expect the possibility of eliminating property tax and increase of personal taxes. In the event this occurs, the IU has been reaching out to Business managers at the school Districts to determine how this will affect funding public education. The 2017-18 assembly returned on January 3, 2017 with 39 new and 197 returning members that were sworn in and adopted the rules of conduct and followed the senate's direction for moving from 24 hours to 6 hours before a vote can be taken. The House and Senate will reconvene on January 23, 2017. Ms. Haywood invited everyone to stay tuned for Governor Wolf's proposed 17-18 budget which will be announced on February 2, 2017. The Senate will meet in March to discuss the proposed budget. Finally, Ms. Haywood stated Pennsylvania ranks 8th in the nation regarding Every Student Succeeds Act. PA scored 80.2 out of 100.
