WHEREIN, under the provisions of the Education Law Section 3602-c, the School District in which a nonpublic school is located is required to furnish special education and related services to parentally-placed students with disabilities attending those schools, and

WHEREIN, under the same law, the district whose children attend such schools are required to pay the costs for special education and related services in accordance with Education Law Section 3602-c and related provisions of the Education Law and Regulations of the Commissioner of Education, therefore

BE IT RESOLVED, that upon recommendation of Superintendent Eleanor Tritt, the Amagansett School Board hereby authorizes the Superintendent of Schools to contract with the Wainscott Common School District for special education and related services for one student attending the Ross School during the 2017/2018 school year. The cost per student for the 2017/2018 school year to be determined based on the related services provided.
