Resolution #105 - Upon motion of Hank Muchnic, seconded by Kristen Peterson and carried 3-0,

WHEREAS, the Board of Education established a voluntary Sick Leave Bank for its salaried, non-instructional employees, including its confidential staff members, on April 13, 2010; and

WHEREAS, the Board amended this Sick Bank on June 28, 2011, and further amended the Bank on July 26, 2016, in order to increase the maximum number of hours to be accumulated in said Bank; and

WHEREAS, upon the recommendation of the Superintendent of Schools, it has been determined that the Bank needs to be amended, again, for operational reasons;

NOW THEREFORE, BE IT RESOLVED, that the April 13, 2010 Sick Bank is hereby amended as follows:

- 1. Amend paragraph 2 to provide that the unused days to be left in the Bank may accumulate up to a maximum of 1500 hours.
- 2. Amend paragraph 3(a) to provide that "the employee must be suffering a catastrophic and incapacitating personal illness/disability/injury or the employee's immediate family member (spouse, parent, child) must be suffering a catastrophic and incapacitating personal illness/disability/injury".
- 3. Amend paragraph 6 and 7 to provide that all decisions relating to eligibility and to the number of hours to be granted shall be initially reviewed and approved by the Board of Education, upon the Superintendent's recommendation. If the employee reapplies to the Bank for additional days under extenuating circumstances as set forth in paragraph 6, the Superintendent may approve subsequent additional days in the best interests of the District, upon prior notification to the Board of Education.
