PURPOSE: The Warrior Hall of Fame is an all-inclusive collection of former Warriors who have distinguished themselves in the area of athletics, the fine arts, academics, or activities while at Henry Sibley/Two Rivers High School and beyond in their post HSHS/TRHS experiences. The Warrior Hall of Fame will pay tribute, recognize, and enhance School District 197's tradition of excellence by honoring alumni, advisors, coaches, and friends for their accomplishments.

NOMINATIONS: Anyone who is willing to use, in good faith, the criteria below for induction can make a nomination. The nomination form starts on the third page of this document. Please email completed forms to prentice.smith@isd197.org, or compete and mail nominations to:

CRITERIA FOR INDUCTION:

The following criteria will be used to evaluate nominees to the Warrior Hall of Fame:

1. The nominee must have a direct connection to School District 197.
 - a. Students: Student nominees become eligible for induction five years after graduating from high school.
 - b. Staff Member: Staff nominees can be present or former staff members.
 - c. Community Member: Community member nominees must have been a loyal and devoted supporter of HSHS/TRHS athletics, arts, academics or activities.

2. Nominees must have distinguished themselves in outstanding achievement, leadership, and/or humanitarian efforts.
3. Nominees must be, or have been, a person of good character, a good citizen, and a credit to the community.
4. A nominee must be voted in per voting rules of the selection committee in order to be inducted into the Warrior Hall of Fame.
5. Deadline for submission of nominations is May 1.

ELECTION OF INDUCTEES:

1. The Selection Committee will vote to select a maximum of five (5) inductees to the Warrior Hall of Fame each year.
2. In years that there are more than 50 nominations, the principal and activities director will pre-screen the nominations and reduce the number reviewed by the committee to 50.
3. Selected nominees must have the support of 75% of the selection committee which must include the high school principal.
4. Those nominated one year but not selected will remain in the nomination pool for ten years for future selection consideration.

INDUCTION CEREMONY and RECOGNITION:

1. An induction ceremony will be held to honor those who have been selected into the Warrior Hall of Fame. The Selection Committee will choose the time and place for the induction ceremony.
2. Pictures and information describing the accomplishments of the inductees will be displayed at Two Rivers High School. Each inductee will also receive a plaque.

SELECTION COMMITTEE MEMBERS:

On an annual basis, the principal will determine the selection committee using the following guidelines.

1. Membership will include
 - a. Principal of Two Rivers High School
 - b. Activities Director of Two Rivers High School
 - c. Three (3) additional current TRHS staff members
 - d. Four (4) at-large community members appointed by the principal/activities director.
 - e. The above Committee will select a chairperson, a secretary, and a treasurer for a two (2) year term. The chairperson, secretary, and treasurer may succeed themselves if agreed upon with a majority vote by the Selection Committee.
 - f. Committee members can't vote for themselves if nominated.
2. Members will ideally serve for a minimum of three years.
