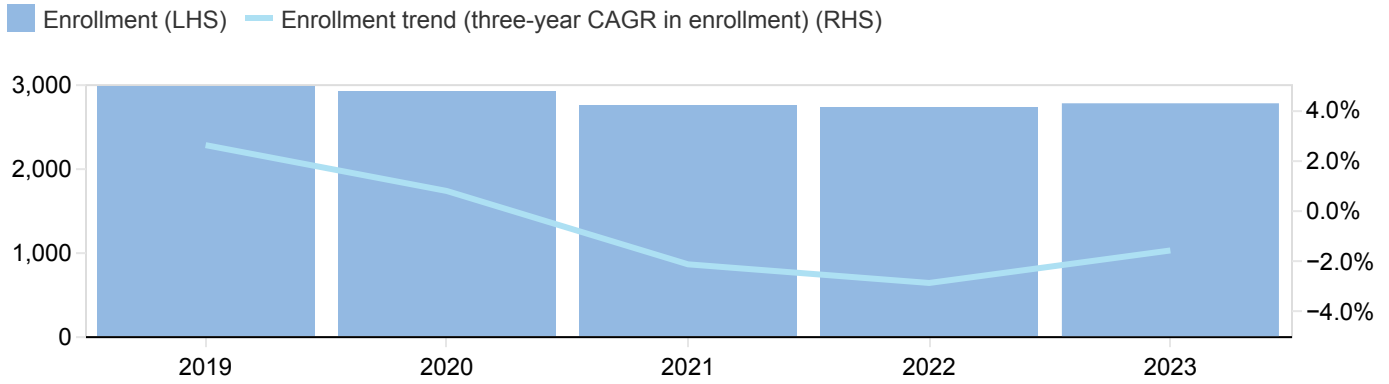

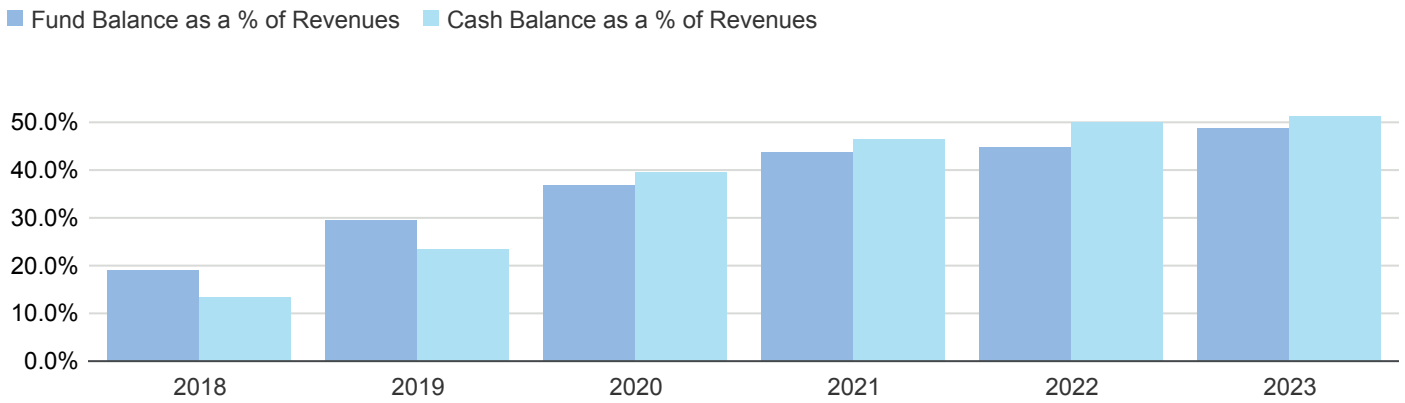

Financial Trends



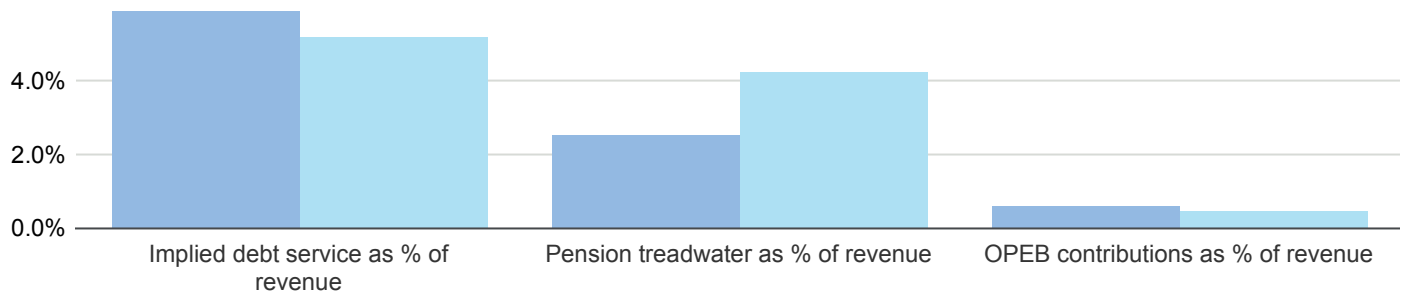
