




COVID-19 Statistics Orange County: Positivity Percentages







California Safe Schools for All

- > Relatively low risks and high benefits for educating students in classrooms, especially in elementary grades.
- Children do not seem to be the major sources of transmission either to each other or to adults, especially in the elementary grades.
- ➤ Low risk of transmission in elementary schools no outbreaks in any OVSD schools.
- ➤ In-person instruction is critical for learning and growth especially in elementary grades.
- We must regularly and equitably address students' academic, social, and emotional needs.



California School Reopening Guidance

- California Department of Public Health (CDPH) recent guidance for schools explicitly indicates a minimum of 4 feet, rather than 6 feet to the extent possible for physical distance between students in classrooms.
- ➤ Layering of mitigation strategies decreases the risk of in-school transmission.
- Layers of protection in OVSD include: Face coverings, stable groups, physical distancing, hand hygiene, health screening, staff testing, close contact screening, and quarantine protocols.

Vaccines for Educators

- There has been an unprecedented mobilization aimed at vaccinating more than 100,000 school employees in Orange County.
- Collaborations between the Orange County Department of Education and the Orange County Health Care Agency to make OC School PODS (points of dispensing).
- ➤ Last week OC School PODs at Capistrano Valley High School in Mission Viejo and La Quinta High School in Westminster delivered more than 6,300 shots to school employees.



Vaccines for Educators

- ➤ New OC School PODs were launched in the Anaheim Union High School District on Monday and another location will open on Wednesday, March 10, in the Saddleback Valley Unified School District.
- ➤ Vaccines are also available at Super PODs, Walgreens, Rite Aid and CVS based on state eligibility requirements, and many school employees have reported successfully receiving their first shots.



OVSD In-Person Phase 3 Reopening

- ➤ 100% in-person is Phase 3 of the in-person instructional model outlined in OVSD's School Reopening and Protection Plan.
- OVSD is committed to working collectively with our union leadership, negotiations teams, administrators, and our staff to get all **elementary students** back on campus **five days a week,** phasing in grade spans each week, for the current in-person school hours.
- > Having students on campus each day allows teachers to better meet the academic, social, and emotional needs of our students.
- It is the right thing to offer our Ocean View community.



In-Person Phase 3 Reopening Transition Impact

- > Work collaboratively with our employee associations.
- ➤ Reconfigure elementary classroom layouts to accommodate students with the minimum four feet social distancing requirement.
- > Hire additional elementary staff and create additional elementary classes on each campus in available rooms.
- > In some instances, elementary students will have a new teacher.
- Reassess safety protocols to keep classrooms safe, emphasizing layers of protection and mitigation strategies.



In-Person Phase 3 Reopening Transition Impact

- As additional details are finalized, you will hear from the District and your principal.
- Anticipate a brief transition period for staff and students.
- > 5 days per week, same hours as in-person Hybrid schedule.
- We suggest that you begin preparing your child for this change.



Next Steps

- ➤ Move forward with classroom and class reconfigurations to accommodate all in-person elementary students on campus 5 days per week.
- Communicate and reinforce COVID-19 layers of protection/mitigation to ensure continued safety of our students and staff.
- Provide communication to elementary families as soon as details are available.
- Continue to facilitate vaccination opportunities for staff.
- Continue to look at ways to improve the existing Hybrid schedule at the Middle School.
- Continue to monitor state directives for school reopening Fall, 2021.
