# Jack Shaw Receives Lifetime Achievement Award In Memoriam

The Board of Trustees presented a Lifetime Achievement Award in memoriam for Jack Shaw, which his wife and partner, Dr. Ellen Shockro, accepted on his behalf. Jack worked tirelessly to bring about community empowerment and renewal in the Oak View community. He brought people together to build credibility, trust, community involvement and safety. He figured out how to bring much-needed services to Oak View, such as educational programs, community service programs, job training, a branch library, a family resource center, a police substation, and medical and dental mobile health clinics. He formed an organization with OVSD and HBUHSD called El Viento, which provided academic support, life experiences, college support and scholarships for many students. It was the beginning of a successful model for educational opportunities in Oak View. Jack was beloved, and



several people spoke on his behalf and stated that there are people in place to carry on his important work.

#### **LCAP**

Dr. Julianne Hoefer, Assistant Superintendent of Educational Services, provided the Board with an update on the Local Control & Accountability Plan (LCAP) which was followed by a public hearing. There are three broad LCAP goals with corresponding action steps: Pupil Outcomes & Conditions of Learning, Targeted Supports, and Engagement. The next step is to finalize the LCAP, and the final plan will be agendized for Board approval on June 28. See the update here.

## **Budget**

Assistant Superintendent Keith Farrow presented Ocean View's 2022-23 Preliminary Budget to the Board, which will come back for final approval on June 28. Components of the Preliminary Budget include general information, assumptions, General Fund revenue, General Fund expenses, General Fund balance summary, and encroachment. California is looking at very healthy public education funding in 2022-23 and the COLA is increasing. However, much of the new funding is one-time money that does not rectify significant issues facing individual districts, e.g., declining enrollment, staffing, pension plan contribution increases, and economic uncertainties. The outlook for next year is positive, but deficit spending is projected in following years.
