Governor's May Revise Budget Update

Keith Farrow, Assistant Superintendent of Administrative Services and Chief Business Official (CBO), provided a budget update following the Governor's May Budget Revision. The Governor's Budget has reductions in one-time funding for the Arts, Music, and Instructional Materials Discretionary Block Grant and Learning Recovery Emergency Block Grant. A significant budgetary challenge facing the state is the unknown revenue impact as a result of personal income taxes not being collected until October. A draft of OVSD's Proposed Budget for 2023-24 will be presented for information at the June 6th Board Meeting. See the Governor's May Revise Budget presentation here.

Certificated Staffing 2023-24

Reagan Headrick, Assistant Superintendent of Human Resources, provided the Board with an update on Certificated staffing for the 2023-24 school year. She discussed timelines, contract language, enrollment, and staffing ratios. Ms. Headrick stated that the District is overstaffed. She also illustrated how low school enrollment creates fewer classes at each grade level, which, in turn, increases staffing challenges as schools strive to meet contract obligations for 27 students to 1 teacher (27:1) for grades K-3 and 32:1 for grades 4-8. Discretionary Block Grant & Prop 28

Dr. Julianne Hoefer, Assistant Superintendent of Educational Services, provided the Board with an update on the Arts, Music & Instructional Materials Discretionary Block Grant and Proposition 28: Arts and Music Schools. The Discretionary Block Grant provides **District** funds for professional development, instructional materials, improving school culture, developing relevant book collections, and other operational expenses. Proposition 28 provides **school** funds for supplemental arts and music education in all TK-12 schools. It stipulates that 80% of the funding must be spent on certificated and classified staff and 20% on training and supplies. Dr. Hoefer asked for Board input regarding how to spend the funding, and will bring a draft plan for review and approval at a future meeting.
